- (3) On March 6, 2019, the reporting person was granted 19,464 options, vesting in three equal annual installments beginning on the first anniversary of the grant date.
- (4) Each performance share represents a contingent right to receive one share of the Issuer's Common Stock based upon the Issuer's cumulative EBITDA (50%) and total free cash flow as a % of sales (50%) over a three-year performance period ending December 31, 2021.
