POWER OF ATTORNEY

Know all by these presents, that the undersigned hereby constitutes and appoints each of (i) the Chief Accounting Officer of Myers Industries, Inc., an Ohio corporation (the "Company"), who is currently Kevin Brackman, and (ii) the Company's Treasurer, who is currently Monica Vinay, and their respective successors, signing singly, with full power of substitution, as the undersigned's true and lawful attorney-in-fact to:
