- (2) The reporting person is a trustee of the Trust, the entity that owns 81,002,271 shares of Common Stock following the Distribution. The reporting person disclaims beneficial ownership of the reported securities held by such Trust except to the extent of her pecuniary interest therein.
- (3) The transaction is the receipt of 200,000 shares of Common Stock, for no consideration, in the Distribution.
- (4) On December 15, 2017, the reporting person made a charitable gift of 200,000 shares of Common Stock.
- (5) The reporting person is a member of Walton Enterprises, LLC, the entity that owns 1,415,891,131 shares of Common Stock. The reporting person disclaims beneficial ownership of the reported securities held by such LLC except to the extent of her pecuniary interest therein.
