

Subject Company: Connecticut Water Service, Inc. (Commission File No.: 0-8084)

This filing relates to the proposed transaction between SJW Group (“SJW Group”) and Connecticut Water Service, Inc. (“CTWS”) pursuant to the Amended and Restated Agreement and Plan of Merger, dated as of May 30, 2018, among SJW Group, Hydro Sub, Inc. and CTWS.

The following email was sent by CTWS’s Director of Corporate Communications to certain town officials on May 31, 2018.

I wanted to reach out to you and forward you the attached press release issued today by Connecticut Water regarding our previously announced merger with SJW Group.

As you may recall, we shared in March 2018 that Connecticut Water’s Board of Directors voted to enter in a merger of equals with SJW Group to create the nation’s 3rd largest water and wastewater utility. The Board considered various alternatives and determined that the merger with the SJW Group provides value and benefits for our shareholders, customers, employees and communities we serve. As discussed at the time of the announcement, there will be no layoffs or job losses as a result of the merger with the SJW Group and we will have our local employees serving customers and communities with our New England headquarters and decision-makers here in Clinton, Connecticut just like they always have.

At this time, Connecticut Water remains subject to the SJW Group merger agreement, and our Board has not changed its recommendation in favor of the merger of equals with SJW Group.

However, this morning Connecticut Water announced that the merger agreement with SJW Group has been amended to allow Connecticut Water, with the assistance of its financial advisors, to solicit proposals for an alternative merger, acquisition or other strategic transaction involving Connecticut Water.

We believe this additional step and public process by the Connecticut Water Board is appropriate to allow all of our stakeholders to have full confidence in the Company’s strategic direction and to know that every viable alternative has been explored. The solicitation period for the receipt and consideration of alternate proposals will end on July 14, 2018.

Connecticut Water’s Board, management team and employees remain focused on delivering a reliable supply of safe drinking water and service, ensuring for public safety through robust public fire protection and being a trusted partner in economic development.
