**Update on Merger with Connecticut Water: Rejection of Proposal from Cal Water**

Dear SJW Team,

As you have seen in the press release we issued today, which is attached here, we have rejected an unsolicited, non-binding indication of interest from California Water Service Group. Cal Water is the third party strategic acquirer identified as “Company X” in our preliminary proxy statement on Form S-4 filed yesterday.

As we emphasized in our release, we continue to be committed to our existing merger agreement with Connecticut Water, which remains on track to close during the fourth quarter of 2018. After a careful and thorough review, our Board determined that our merger of equals with Connecticut Water has greater potential than Cal Water’s proposal to create significant long-term value for our shareholders. Additionally, we believe our existing transaction with Connecticut Water provides greater long-term benefits for our customers, all of our employees and the communities we serve.
