The Restricted Stock Units will be settled, at the reporting person's election, in 100% shares of common stock, 50% in common stock and 50% in cash, or 100% in cash.
- (2) The Restricted Stock Units award was granted and was effective on June 29, 2020, and vests in four equal, annual installments beginning on February 19, 2021, and will be settled in four equal, annual installments beginning February 19, 2021.
