- The Restricted Stock Units vest and will be settled as follows: 260 will vest on each of February 20, 2018 and February 20, 2019.
- The Restricted Stock Units vest and will be settled as follows: 261 will vest on each of February 20, 2018; February 20, 2019; and February 20, 2020.
- The Restricted Stock Units vest and will be settled in four equal, annual installments beginning on February 20, 2018.
- Each Restricted Stock Unit represents a contingent right to receive the economic equivalent of one share of the Company's common stock. The Restricted Stock Units will be settled, at the reporting person's election, in 100% shares of common stock, 50% in common stock and 50% in cash, or 100% in cash.
