
3. Effectiveness. This Power of Attorney shall become effective upon execution and is not affected by subsequent disability or incapacity of the principal.



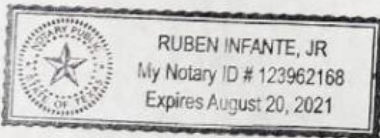
