- (3) Option vests 1/3 per year beginning on the first anniversary of the date of grant.
- (4) The dividend equivalent rights accrued on previously awarded restricted stock units (RSUs) which vest proportionately with the RSUs to which they relate. Each dividend equivalent right is the economic equivalent of one share of American Eagle Outfitters common stock.
- (5) The restricted stock units vest in three equal annual installments beginning on the first anniversary of the date of grant.
