A. Prepare, execute in the undersigned's name and on the undersigned's behalf, and submit to the Securities and Exchange Commission (the SEC) a Form ID, including amendments thereto, and any other documents necessary or appropriate to obtain codes and passwords enabling the undersigned to make electronic filings with the SEC of reports required by

Section 16(a) of the Securities and Exchange Act of 1934, as amended (the Exchange Act), or any successor rule or regulation of the SEC;

- B. Prepare, execute, acknowledge, deliver and file such Forms 3, 4 and 5 (including any amendments thereto) with respect to the securities (including derivative securities) of Highwoods Properties, Inc.
