Item 1.01. Entry into a Material Definitive Agreement.

On September 4, 2013 Synacor, Inc. (“Synacor”) entered into Amendment #4 to the Master Services and Linking Agreement (the “Amendment”) with Toshiba America Information Systems, Inc. (“Toshiba”) with an effective date of June 30, 2012.

The Amendment amends that certain Master Services and Linking Agreement dated July 1, 2010 by and between Synacor and Toshiba (the “Agreement”) to extend the term of the Agreement until September 30, 2014.
