This cumulative total does not represent additional Restricted Stock Units granted to the reporting person, but is merely a total of all awards reported separately on this SEC Form 4.
- (5) These stock units will be automatically converted into shares of stock upon the reporting person's retirement from the Board of Directors of the Company.
