Explanation of Responses:

- (1) Each Performance RSU represents a contingent right to receive one share of the Issuer's common stock.
- (2) The vesting of these performance-based RSUs was tied to the Issuer's achievement of a total shareholder return, or TSR, performance goal, which was measured over a two-year performance period from January 24, 2016 to January 24, 2018, versus the TSR realized for the same period by the Russell 2000 Index. Based on the Issuer's TSR performance during this period, the shares awarded to the Reporting Person vested at 200% of the target amount.
- (3) The shares of common stock underlying the performance-based restricted stock units reported as disposed herein were earned, but were retained (and not issued) by the Issuer in satisfaction of tax withholding obligations associated with the vesting of such units.
- (4) The performance-based restricted stock units reported as disposed herein were settled for shares of the Issuer's common stock.
