- 1/4th of the shares issuable pursuant to the option shall vest one year after the vesting commencement date of June 11, 2018 and an additional 1/48th of the shares issuable pursuant to the option shall vest each month thereafter, subject to the Reporting Person's continuous service to the Issuer on each such date. The Reporting Person will be eligible to participate in the Issuers's Change of Control Acceleration Plan. If the Reporting Person elects to participate in the Issuers's Change of Control Acceleration Plan, unvested shares will be subject to acceleration upon the occurrence of certain events described therein.
- Shares subject to the option vests ratably monthly over 48 months from vesting commencement date of February 7, 2019 subject to cliff vesting for all months prior to the one year anniversary of June 11, 2018.
