**Explanation of Responses:**

- Represents units acquired under the Trane Deferred Compensation Plan ("TDCP"). The units are to be converted on a one-for-one basis and settled in ordinary shares of the Company, less applicable withholding taxes, upon the reporting person's termination of employment with the Company, or earlier or later upon certain elections.
- The option vested in three equal annual installments on the first, second and third anniversaries of the date of grant.
- The option, originally issued by Trane Inc., became fully vested and exercisable on June 5, 2008, the effective date of the merger between Trane Inc. and a wholly-owned subsidiary of Ingersoll-Rand Company Limited, the predecessor issuer to Ingersoll-Rand plc.
