Controladora Vuela Compañía de Aviación, S.A.B. de C.V. (“Volaris” or the “Company”) (BMV:VOLAR) (NYSE: VLRS) announced today that it filed its annual report under the Form 20-F for the fiscal year ended December 31, 2019 with the U.S. Securities and Exchange Commission (the “SEC”).

Volaris offers up to 131 daily flight segments on routes that connect 40 cities in Mexico and 25 cities in the United States and Central America with one of the youngest fleet in the Americas. Volaris targets passengers who are visiting friends and relatives (VFR), cost-conscious business people and leisure travelers in Mexico and to select destinations in the United States and Central America.
