- Includes 27,649 shares of common stock related to RSUs granted as part of the director's 2019 annual equity award which provided for vesting in quarterly installments on August 3, 2019, November 3, 2019, February 3, 2020, and May 3, 2020, subject to the reporting person's continuous service with Corindus through each such vesting date.
- Hudson Executive Capital LP, a Delaware limited partnership ("Hudson Executive"), as the investment advisor to certain affiliated investment funds, and HEC Management GP LLC, a Delaware limited liability company ("Management GP"), as the general partner of Hudson Executive, may be deemed to be the beneficial owners of the securities. By virtue of Mr. Braunstein's position as Managing Partner of Hudson Executive and Managing Member of Management GP, Mr. Braunstein may be deemed to be the beneficial owner of the securities reported for purposes of Rule 16a-1(a). Mr. Braunstein disclaims any beneficial ownership of the securities reported, except to the extent of any pecuniary interest therein.
