Sunoco LP Maintains Quarterly Distribution 4Q 2019 Earnings Release and Earnings Call Dates Also Announced

DALLAS, January 27, 2020 - Sunoco LP (NYSE: SUN) ("SUN") announced that the Board of Directors of its general partner declared a quarterly distribution for the fourth quarter of 2019 of \$0.8255 per common unit, which corresponds to \$3.3020 per common unit on an annualized basis. The distribution will be paid on February 19, 2020 to common unitholders of record on February 7, 2020.

SUN will release its fourth quarter 2019 financial and operating results after the market closes on Wednesday, February 19. In conjunction with the news release, management will hold a conference call on Thursday, February 20 at 8:00 a.m. Central Time (9:00 a.m. Eastern Time) to discuss SUN's results.
