Shares of the Issuer's Class B Common Stock will be delivered to the Reporting Person following vesting.
- Represents an award of RSUs. The RSUs vest as to 100% of the shares on the earlier of: (i) the date of the next annual meeting of the Issuer's stockholders and (b) October 5, 2019, subject to the continuing service of the Reporting Person on the vesting date. Each RSU represents a contingent right to receive one share of the Issuer's Class A Common Stock upon settlement for no consideration. Shares of the Issuer's Class A Common Stock will be delivered to the Reporting Person following vesting.
