- (1) Represents cash retainer amounts deferred as fully vested units under the Schneider National, Inc. Director Deferred Compensation Program. The units will be settled in shares of Class B common stock in accordance with the terms of the Program. Although the units were not credited to the reporting person's account until Board approval on July 24, 2017, the number of units was determined based on the closing share price of \$23.04 on July 3, 2017 pursuant to the terms of the Company's Director Compensation Policy.
- (2) Consists of 3,290 fully vested shares issued as equity retainer amounts under the Schneider National, Inc. 2017 Omnibus Incentive Plan and 1,357 fully vested deferred stock units issued as equity retainer amounts and deferred under the Schneider National, Inc. Director Deferred Compensation Program. The units will be settled in shares of Class B common stock in accordance with the terms of the Program.
