This Amendment No. 1 to Schedule 13D amends and supplements the Schedule 13D originally filed on April 21, 2017 (the “Original Schedule 13D”), and is being filed jointly on behalf of the Donald J. Schneider Childrens Trust #2 f/b/o Mary P. DePrey, a Wisconsin trust (the “Childrens Trust”), the Donald J. Schneider 2000 Trust f/b/o Mary P. DePrey (the “2000 Trust,” and together with the Childrens Trust, the “Trusts”), and Mary P. DePrey, in her individual capacity and as a co-trustee of the Trusts (together the “Reporting Persons”), relating to the shares of Class A common stock, no par value per share (“Class A Common Stock”), and Class B common stock, no par value per share (“Class B Common Stock”), of Schneider National, Inc., a Wisconsin corporation.

Unless otherwise defined or modified below, capitalized terms used in this Amendment No. 1 to Schedule 13D shall have the meaning ascribed to them in the Original Schedule 13D. All disclosure for items contained in the Original Schedule 13D where no new information is provided for such item in this Amendment No.1 to Schedule 13D is incorporated herein by this reference.

**Item 3. Source and Amount of Funds or Other Consideration**

Item 3 of the Original Schedule 13D is supplemented with the following:

Between April 11, 2017 and January 31, 2018, Ms. DePrey disposed of 40,000 shares of Class B Common Stock by gift and acquired 29,247 shares of Class B Common Stock by gift. As of January 31, 2018, the Reporting Persons beneficially owned an aggregate of 16,605,900 shares of Class A Common Stock and 2,925,717 shares of Class B Common Stock.
