These restricted stock units will vest subject to Mr. Fowke's continuous employment through the first to occur of February 26, 2025 or upon his replacement with a permanent chief executive officer.
- (2) Was AEP Stock Price at the time of the transaction.
- (3) The reporting director deferred the receipt of his \$40,000 quarterly cash retainer into the AEP Stock Fund under the AEP Stock Unit Accumulation Plan for Non-Employee Directors. The reporting director may transfer amounts in the AEP Stock Fund into an alternative investment at any time.
- (4) Stock Units are paid to the director in cash or shares upon termination of service unless the director has elected to defer payment for a period that results in payment commencing not later than five years thereafter.
- (5) Includes units of reinvested dividends acquired pursuant to the dividend reinvestment feature of the Plan.
