Explanation of Responses:

- (1) On 10/1/20, Ms. Gray was granted 5,203 performance restricted stock units. These PRSU's vested on the third anniversary of the grant date based on the achievement of a three-year performance measure.
- (2) On 10/1/21, Ms. Gray was granted restricted stock units that convert into 818 shares of common stock on a 1 for 1 basis. These restricted stock units vested on 10/1/24.
- (3) On 10/1/21, Ms. Gray was granted 2,452 performance restricted stock units. These PRSU's vested on the third anniversary of the grant date based on the achievement of a three-year performance measure.
- (4) On 10/1/22, Ms. Gray was granted restricted stock units that convert into 894 shares of common stock on a 1 for 1 basis. These restricted stock units vested on 10/1/24.
- (5) On 10/1/23, Ms. Gray was granted restricted stock units that convert into 1,061 shares of common stock on a 1 for 1 basis. These restricted stock units vested on 10/1/24.
- (6) On October 1, 2024, Ms. Gray was granted 1,978 restricted stock units. These restricted stock units will vest 1/3 per year for three years.
- (7) On October 1, 2024, Ms. Gray was granted 1,978 performance restricted stock units. The PRSU's will vest on the third anniversary of the grant date based on the achievement of a three-year performance measure.
