Vesting of the performance-based portion is dependent upon the extent to which the two-year performance metric is achieved, with any earned shares vesting in two equal installments on February 21 of each of 2020 and 2021.
- These shares of unvested restricted stock were forfeited due to a failure to achieve a specific level of performance required for vesting.
- This is a legacy defined contribution plan sponsored by the Issuer.
