- Represents a stock award of deferred shares of the Issuer's Class A Common Stock having a value of \$160,000 granted on the date of election as a director at the Annual Meeting of Shareholders held on February 6, 2020. Pursuant to the election made under the Deferred Stock Agreement for Directors, these deferred shares shall be settled and paid in five equal annual installments beginning 2 years after termination of the Reporting Person's service as a member of the Issuer's board of directors.
- Includes 9,577.675 shares of the Issuer's Class A Common Stock acquired by the Reporting Person pursuant to the Deferred Fee Plan for Directors, which shares shall be settled and paid 180 days after termination of the Reporting Person's service as a member of the Issuer's board of directors and 2,005.767 shares of the Issuer's Class A Common Stock acquired by the Reporting Person pursuant to the Deferred Stock Agreement for Directors, which shares shall be settled and paid in five equal annual installments beginning 2 years after termination of the Reporting Person's service as a member of the Issuer's board of directors.
