Explanation of Responses:

- Represents shares of the Issuer's Class A Common Stock purchased for the Reporting Person's account under the Issuer's Employee Stock Purchase Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisitions are exempt from Section 16 concurrent reporting requirements pursuant to Rule 16b-3.
- The Reporting Person transferred shares from his personal stock account into an account held by the White Family Foundation thereby changing the ownership of the Class A Common Stock from direct to indirect.

- This is a weighted average price. These shares were sold in multiple transactions on December 22, 2017 at prices ranging from \$80.90 to \$81.01, inclusive.
