The Restricted Stock Units will be settled, at the reporting person's election, in 100% shares of common stock, 50% in common stock and 50% in cash, or 100% in cash.
- The Restricted Stock Units vest and will be settled as follows: 194 will vest on each of February 18, 2022 and February 20, 2023.
- The Restricted Stock Units vest and will be settled as follows: 295 will vest on each of February 18, 2022, February 20, 2023, and February 20, 2024.
- The Restricted Stock Units vest and will be settled as follows: 527 will vest on each of February 18, 2022, February 20, 2023, February 20, 2024, and February 20, 2025.
