Explanation of Responses:

- (1) Only vested shares can be exercised under this option. 25% of the shares will vest on 3/3/22; the remaining shares will vest monthly over the following 36 months so that the option will be fully vested and exercisable on 3/3/25.
- (2) Each Performance-based Restricted Stock Unit ("RSU's") represents the right to receive, following vesting, up to 200% of one share of Cirrus Logic, Inc. common stock. The resulting number of shares of common stock acquired upon vesting of the performance-based RSU's is contingent upon the achievement of pre-established performance metrics, as approved by the Company's Compensation Committee, over a three-year performance period beginning on March 3, 2021, and ending on March 3, 2024.
- (3) Each restricted stock unit represents a contingent right to receive one share of Cirrus Logic common stock.
- (4) 100% of the restricted stock units will vest on 3/3/24, the 3-year anniversary of the grant date.
