- (3) The reporting person's original Form 4 reported the disposition by the MRK Trust of shares of Common Stock, but inadvertently reported that, following such disposition, the MRK Trust owned 57,008 shares of Common Stock. As reported in this amendment, however, following such disposition the MRK Trust owned 63,684 shares of Common Stock.
