(Sioux Falls, South Dakota – November 26, 2013) Meta Financial Group, Inc. ® (the “Company”) (NASDAQ: CASH) announced that the Company will pay a cash dividend of \$0.13 per share for the first fiscal quarter of 2014. This dividend will be payable on or about January 1, 2014 to shareholders of record as of December 10, 2013.

At September 30, 2013, the Company had total assets of \$1.7 billion and shareholders’ equity of \$143.0 million.

Corporate Profile: Meta Financial Group, Inc. ®, (“Meta Financial” or the “Company”) is the holding company for its wholly-owned subsidiary, MetaBank TM (the “Bank”). MetaBank is a federally-chartered savings bank with four market areas: Northwest Iowa Market, Brookings Market, Central Iowa Market, Sioux Empire Market; and the Meta Payment Systems® prepaid card division. Eleven retail banking offices and one administrative office support customers throughout northwest and central Iowa, and in Brookings and Sioux Falls, South Dakota.
