- (1) Gift without consideration.
- (2) The shares are held by the Debora C. Shoquist Revocable Living Trust, of which the Reporting Person is a trustee.
- (3) Represents the number of shares earned based on the achievement of a pre-established operating plan performance goal during the Issuer's fiscal year ended January 28, 2024. The shares earned will vest as to 25% on March 20, 2024 and as to 6.25% of the shares every three months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
- (4) The shares represent restricted stock units that were received as an award, for no consideration.
- (5) Represents the number of shares earned based on achievement of a pre-established performance goal from January 31, 2021 through January 28, 2024. The shares earned will vest as to 100% on March 20, 2024, such that the shares will be fully vested on approximately the three (3) year anniversary of the date of grant.
- (6) Includes 110 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on February 29, 2024.
