Explanation of Responses:

- (1) Represents the number of shares earned based on the achievement of a pre-established operating plan performance goal during the Issuer's fiscal year ended January 26, 2025. The shares earned will vest as to 25% on March 19, 2025 and as to 6.25% of the shares every three months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
- (2) The shares represent restricted stock units that were received as an award, for no consideration.
- (3) Includes 1,101 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on February 28, 2025.
- (4) Represents the number of shares earned based on achievement of a pre-established performance goal from January 30, 2022 through January 26, 2025. The shares earned will vest as to 100% on March 19, 2025, such that the shares will be fully vested on approximately the three (3) year anniversary of the date of grant.
- (5) The shares are held by the Ajay K. Puri Revocable Trust dtd 12/10/2015, of which the Reporting Person is trustee.
- (6) The shares are held by The Puri 2019 Irrevocable Children's Trust dtd 12/06/2019, of which the Reporting Person is trustee. Mr. Puri disclaims beneficial ownership of the shares held by the trust except to the extent of his pecuniary interest therein, if any.
