This Amendment No. 9 ("Amendment No. 9") amends and supplements the statement on Schedule 13D filed with the Securities and Exchange Commission (the "SEC") on February 4, 2019 (the "Original Schedule 13D"), Amendment No. 1 filed with the SEC on February 25, 2019 ("Amendment No. 1"), Amendment No. 2 filed with the SEC on March 8, 2019 ("Amendment No. 2"), Amendment No. 3 filed with the SEC on October 15, 2019 ("Amendment No. 3"), Amendment No. 4 filed with the SEC on November 7, 2019 ("Amendment No. 4"), Amendment No. 5 filed with the SEC on November 26, 2019 ("Amendment No. 5"), Amendment No. 6 filed with the SEC on December 23, 2019 ("Amendment No. 6"), Amendment No. 7 filed with the SEC on January 2, 2020 ("Amendment No. 7") and Amendment No. 8 filed with the SEC on March 20, 2020 ("Amendment No. 8" and together with the Original Schedule 13D, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5, Amendment No. 6, Amendment No. 7, Amendment No. 8 and this Amendment No. 9, the "Schedule 13D") with respect to the common shares, \$1.00 par value (the "Common Shares") of Argo Group International Holdings, Ltd., a Bermuda exempted company limited by shares (the "Issuer"). Capitalized terms used herein and not otherwise defined in this Amendment No. 9 have the meanings set forth in the Schedule 13D. This Amendment No. 9 amends Items 3 and 5 as set forth below.

Item 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item 3 of the Schedule 13D is hereby amended and restated as follows:

The Common Shares beneficially owned by Voce Capital Management were purchased with the working capital of the Voce Funds (which may, at any given time, include margin loans made by brokerage firms in the ordinary course of business) in open market purchases. The aggregate purchase price of the Common Shares beneficially owned by Voce Capital Management is approximately \$167,964,472 including brokerage commissions.

Item 5. INTEREST IN SECURITIES OF THE ISSUER

Item 5 of the Schedule 13D is hereby amended and restated as follows:

(a) The aggregate percentage of Common Shares reported as beneficially owned by each person named herein is based upon 34,499,456 Common Shares outstanding as of March 2, 2020, which is the total number of Common Shares outstanding as reported in the Issuer's Proxy Statement filed with the Securities and Exchange Commission on March 16, 2019.

As of the close of business on April 17, 2020, Voce Capital Management beneficially owned 3,021,595 Common Shares, constituting approximately 8.8% of the Common Shares outstanding. Voce Capital, as the sole managing member of Voce Capital Management, may be deemed to beneficially own the 3,021,595 Common Shares beneficially owned by Voce Capital Management, constituting approximately 8.8% of the Common Shares outstanding. Mr. Plants, as the sole managing member of Voce Capital, may be deemed to beneficially own the 3,021,595 Common Shares beneficially owned by Voce Capital Management, constituting approximately 8.8% of the Common Shares outstanding.

As of the close of business on April 17, 2020, the Reporting Persons collectively beneficially owned an aggregate of 3,021,595 Common Shares, constituting approximately 8.8% of the Common Shares outstanding.

Each Reporting Person disclaims beneficial ownership with respect to any Common Shares other than the shares owned directly and of record by such Reporting Person.

(b) By virtue of their respective positions with Voce Capital Management, each of Voce Capital and Mr. Plants may be deemed to have shared power to vote and dispose of the Shares reported beneficially owned by Voce Capital Management.

(c) Schedule A attached hereto lists all transactions in Common Shares of the Issuer by the Reporting Persons since the filing of Amendment No. 8.
