The Reporting Person also indirectly owns 500 shares of issuer's common stock held by Reporting Person's spouse (Reporting Person disclaims beneficial ownership of these shares) and 19,139 shares of the issuer's common stock held by a trust for the Brush Engineered Materials Inc. Deferred Compensation Plan and the 1997 Incentive Plan.
