## **Explanation of Responses:**

- (1) These shares were acquired upon vesting of performance share units for the 2015-2017 performance period, based on the Issuer's average pre-tax operating income and relative total shareholder return over that period.
- (2) Shares were surrrendered to CNO Financial Group, Inc. to cover required tax withholding on vesting of performance share units.
- (3) Restricted stock units convert into common stock on a one-for-one basis.
- (4) The restricted stock units vest in three equal annual installments beginning March 25, 2019.
- (5) Restricted stock units were surrendered to CNO Financial Group, Inc. to cover required tax withholding.
- (6) One-half of these options becomes exercisable on February 21, 2020 and the other one-half becomes exercisable on February 21, 2021.
