- (3) The exercise price increases over the term of the option at a rate equal to the 10-year Treasury bond yield as of the date of grant (\$14.70). On October 11, 2012, the exercise price was \$20.3917.
- (4) The transaction was executed in multiple trades at prices ranging from \$64.00 to \$64.05. The price reported above reflects the weighted average sale price.
