- (2) The exercise price increases over the term of the option at a rate equal to the 10-year Treasury bond yield as of the date of grant (\$14.70). On November 13, 2012, the exercise price was \$20.4671.
- (3) The transaction was executed in multiple trades at prices ranging from \$62.34 to \$62.92. The price reported above reflects the weighted average sale price. - (4) The options become exercisable in four equal installments on May 1, 2005, 2006, 2007 and 2008.
