- (6) The exercise price increases over the term of the option at a rate equal to the 10-year Treasury bond yield as of the date of grant (\$14.70). On November 12, 2012, the exercise price was \$20.4648.
- (7) The transaction was executed in multiple trades at prices ranging from \$62.71 to \$63.41. The price reported above reflects the weighted average sale price. The reporting person hereby undertakes to provide upon request to the SEC staff, Morningstar or a shareholder of Morningstar full information regarding the number of shares and prices at which the transaction was effected.
- (8) The options become exercisable in four equal installments on May 1, 2005, 2006, 2007 and 2008.
