Mr. Zuckerberg is the sole trustee of the 2006 Trust and, therefore, is deemed to have sole voting and investment power over the securities held by CZI.

- The reported price in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$268.48 to \$269.43 per share.
