Explanation of Responses:

- (1) Each Restricted Stock Unit ("RSU") represents a contingent right to receive 1 share of the Issuer's Class A Common Stock upon settlement.
- (2) The RSUs vest as to 100% of the total shares on May 15, 2021; provided, however, in the event that (i) the Issuer's 2021 Annual Meeting of Stockholders is held prior to May 15, 2021; and (ii) the reporting person does not stand for re-election at, or is not re-elected at, the 2021 Annual Meeting of Stockholders (but the reporting person continues to serve on the Board until the date of such meeting), then 100% of the total shares shall vest on the date of the 2021 Annual Meeting of Stockholders.
- (3) The RSUs vest quarterly as to 1/16th of the total RSUs, beginning on August 15, 2020, subject to continued service through each vesting date.
