Explanation of Responses:

- Each RSU represents the contingent right to receive one share of Class A Common Stock.
- The RSUs issued pursuant to the LTIP vest and become payable in two equal annual installments beginning on March 16, 2019. The RSUs will be settled in shares of Class A Common Stock upon vesting, subject to earlier settlement upon death or disability or a change of control of the Issuer.
- The RSUs issued pursuant to the LTIP vest and become payable in three equal annual installments beginning on March 16, 2019. The RSUs will be settled in shares of Class A Common Stock upon vesting, subject to earlier settlement upon death or disability or a change of control of the Issuer.
- The RSUs issued pursuant to the LTIP vest and become payable in four equal annual installments beginning on March 16, 2019. The RSUs will be settled in shares of Class A Common Stock upon vesting, subject to earlier settlement upon death or disability or a change of control of the Issuer.
