## **Sunoco LP Maintains Quarterly Distribution**

## 2Q 2020 Earnings Release and Earnings Call Dates Also Announced

**DALLAS**, July 28, 2020 - Sunoco LP (NYSE: SUN) ("SUN") announced that the Board of Directors of its general partner declared a quarterly distribution for the second quarter of 2020 of \$0.8255 per common unit, which corresponds to \$3.3020 per common unit on an annualized basis. The distribution will be paid on August 19, 2020 to common unitholders of record on August 7, 2020.

SUN will release its second quarter 2020 financial and operating results after the market closes on Wednesday, August 5. In conjunction with the news release, management will hold a conference call on Thursday, August 6 at 8:00 a.m. Central Time (9:00 a.m. Eastern Time) to discuss SUN's results.
