Explanation of Responses:

- (1) Represents Restricted Stock Units (RSUs), of which 30% shall vest on July 1, 2022 (Initial RSU Vesting Date), 7.5% shall vest on the quarterly anniversary of the Initial RSU Vesting Date for each of the next 4 quarters and 5% shall vest on the quarterly anniversary of the Initial RSU Vesting Date for each of the next 8 quarters thereafter, subject to the Reporting Person's continuing to be a Service Provider for the Issuer. Upon vesting of these RSUs, the Reporting Person will receive shares of Class A Common Stock of the Issuer.
- (2) Represents RSUs, of which 25% shall vest on each of January 1, 2022, July 1, 2022, January 1, 2023 and July 1, 2023, subject to the Reporting Person's continuing to be a Service Provider for the Issuer. Upon vesting of these RSUs, the Reporting Person will receive shares of Class A Common Stock of the Issuer.
