Explanation of Responses:

- Represents Restricted Stock Units (RSUs), of which 30% shall vest on November 1, 2020 (Initial RSU Vesting Date), 7.5% shall vest on the quarterly anniversary of the Initial RSU Vesting Date for each of the next 4 quarters and 5% shall vest on the quarterly anniversary of the Initial RSU Vesting Date for each of the next 8 quarters thereafter, subject to the Reporting Person's continuing to be a Service Provider for the Issuer. Upon vesting of these RSUs, the Reporting Person will receive shares of Class A Common Stock of the Issuer.
- 30% of the shares underlying the option shall vest on October 14, 2020 (Initial Option Vesting Date), 7.5% shall vest on the quarterly anniversary of the Initial Option Vesting Date for each of the next 4 quarters and 5% shall vest on the quarterly anniversary of the Initial Option Vesting Date for each of the next 8 quarters thereafter, subject to the Reporting Person's continuing to be a Service Provider for the Issuer.
