**Explanation of Responses:**

- (1) Includes 123 shares acquired by the Reporting Person under the Issuer's 2015 Employee Stock Purchase Plan on November 15, 2018.
- (2) The shares were sold pursuant to a 10b5-1 trading plan.
- (3) The sale price for this transaction represents the weighted average sale price of the shares sold, ranging from \$58.23 to \$59.84 per share. Upon request by the Commission staff, the Issuer or a security holder of the Issuer, the Reporting Person will provide full information regarding the number of shares sold at each separate price.
- (4) 36,774 of the shares underlying the option have vested as of December 24, 2018. The remaining 16,716 shares shall vest in 5 equal quarterly installments beginning on March 9, 2019, subject to the Reporting Person's continued employment with the Company.
- (5) 29,601 of the shares underlying the option have vested as of December 24, 2018. The remaining 38,058 shares shall vest in 9 equal quarterly installments beginning on February 27, 2019, subject to the Reporting Person's continued employment with the Company.
