- 25% of the options vested on August 4, 2017 and the remaining 75% vested in 12 equal quarterly installments thereafter.
- 25% of the options vested on February 25, 2020 and the remaining options vest in 12 equal quarterly installments thereafter, subject to the Reporting Person's continued employment with the Issuer.
