Notes to Consolidated Financial Statements
(Unaudited)
(In millions, except per share and share data)

1. Business

BrightView Holdings, Inc. (the “Company” and, collectively with its consolidated subsidiaries, “BrightView”) provides landscape maintenance and enhancements, landscape development, snow removal and other landscape related services for commercial customers throughout the United States. BrightView is aligned into two reportable segments: Maintenance Services and Development Services.

Basis of Presentation

These consolidated financial statements have been prepared by the Company in accordance with accounting principles generally accepted in the United States of America (“GAAP”) for interim reporting and are unaudited.

In the opinion of management, the accompanying unaudited consolidated financial statements include all adjustments, including normal, recurring accruals that are necessary for a fair presentation of the Company’s operations for the periods presented in conformity with GAAP. All intercompany activity and balances have been eliminated from the consolidated financial statements. The consolidated results of operations for the interim periods presented are not necessarily indicative of results for the full year.

The Consolidated Balance Sheet as of September 30, 2025, presented herein, has been derived from the Company’s audited consolidated financial statements as of and for the fiscal year ended September 30, 2025, but does not include all disclosures required by GAAP, for annual financial statements. For a more complete discussion of the Company’s accounting policies and certain other information, refer to the audited consolidated financial statements and the notes thereto included in the Company’s annual report on Form 10-K for the fiscal year ended September 30, 2025, filed with the Securities and Exchange Commission (“SEC”).

Use of Estimates

The preparation of the consolidated financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the consolidated financial statements and the reported amounts of revenues and expenses during the period. On an ongoing basis, management reviews its estimates, including those related to allowances for doubtful accounts, revenue recognition, self-insurance reserves, estimates related to the Company’s assessment of goodwill for impairment, useful lives for depreciation and amortization, realizability of deferred tax assets, and litigation based on currently available information. Changes in facts and circumstances may result in revised estimates and actual results may differ from estimates.

2. Recent Accounting Pronouncements

Segment Reporting

In November 2023, the FASB issued ASU No. 2023-07, *Segment Reporting (Topic 280): Improvements to Reportable Segment Disclosures*. The ASU expands public entities' segment disclosures by requiring disclosure of significant segment expenses that are regularly provided to the chief operating decision maker and included within each reported measure of segment profit or loss, an amount and description of its composition for other segment items, and interim disclosures of reportable segment's profit or loss and assets. The purpose of the guidance is to enable investors to better understand an entity's overall performance and assess potential future cash flows. The Company adopted the updated accounting guidance on a retrospective basis for the year ended September 30, 2025. The adoption of ASU No. 2023-07 did not have a material impact on the Company's consolidated financial statements. Refer to Note 12 "Segments" to our consolidated financial statements for related disclosures.

Disaggregation of Income Statement Expenses

In November 2024, the FASB issued ASU No. 2024-03, *Income Statement (Subtopic 220-40): Expense Disaggregation Disclosures*. The ASU enhances disclosure of income statement expense categories to improve transparency and provide financial

statement users with more detailed information about the nature, amount, and timing of expenses impacting financial performance. In January 2025, the FASB issued ASU No. 2025-01 to clarify the effective date of the update. The amendment is effective for annual periods beginning after December 15, 2026 and interim periods beginning after December 15, 2027. The Company is in the process of evaluating the impact of ASU No. 2024-03 on its consolidated financial statements.

Accounting for Software Costs

In August 2025, the FASB issued ASU No. 2025-06, *Intangibles (Subtopic 350-40): Goodwill and Other Internal-Use Software*. The ASU removes all reference to prescriptive and sequential software development stages and requires entities to start capitalizing software costs when both management has authorized and committed to funding the software project and it is probable that the project will be completed and the software will be used to perform the function intended. The amendment is effective for annual periods beginning after December 15, 2027, and interim periods within those annual reporting periods. The Company is in the process of evaluating the impact of ASU No. 2025-06 on its consolidated financial statements.

Payment-in-Kind Dividends

In April 2026, the FASB issued ASU No. 2026-01, *Equity (Topic 505): Initial Measurement of Payment-in-Kind Dividends on Equity-Classified Preferred Stock*. The ASU standardizes the accounting for payment-in-kind dividends on equity-classified preferred stock. The amendment is effective for annual periods beginning after December 15, 2026, and interim periods within those annual reporting periods. The Company is in the process of evaluating the impact of ASU No. 2026-01 on its consolidated financial statements.

3. Revenue

The Company's revenue is generated from Maintenance Services and Development Services. The Company generally recognizes revenue from the sale of services as the services are performed, typically ratably over the term of the contract(s), which the Company believes to be the best measure of progress. The Company recognizes revenues as it transfers control of products and services to its customers. The Company recognizes revenue in an amount reflecting the total consideration it expects to receive from the customer. Revenue is recognized according to the following five step model: (1) identify the contract with a customer, (2) identify the performance obligations in the contract, (3) determine the transaction price, (4) allocate the transaction price to the performance obligations in the contract, and (5) recognize revenues when a performance obligation is satisfied. The Company determined that for contracts containing multiple performance obligations, stand-alone selling price is readily determinable for each performance obligation and therefore allocation of the transaction price to multiple performance obligations is not necessary. The transaction price will include estimates of variable consideration, such as returns and provisions for doubtful accounts and sales incentives, to the extent it is probable that a significant reversal of revenue recognized will not occur. In all cases, when a sale is recorded by the Company, no significant uncertainty exists surrounding the purchaser's obligation to pay.

Maintenance Services

The Company's Maintenance Services revenues are generated primarily through landscape maintenance services and snow removal services. Landscape maintenance services that are primarily viewed as non-discretionary, such as lawn care, mowing, gardening, mulching, leaf removal, irrigation and tree care, are provided under recurring annual contracts, which typically range from one to three years in duration and are generally cancellable by the customer with 30-90 days' notice. Snow removal services are provided on either fixed fee based contracts or per occurrence contracts. Both landscape maintenance services and snow removal services can also include enhancement services that represent supplemental maintenance or improvement services generally provided under contracts of short duration related to specific services. Revenue for landscape maintenance and snow removal services under fixed fee models is recognized over time using an output based method. Additionally, a portion of the Company's recurring fixed fee landscape maintenance and snow removal services are recorded under the series guidance. The right to invoice practical expedient is generally applied to revenue related to landscape maintenance and snow removal services performed in relation to per occurrence contracts as well as enhancement services. When use of the practical expedient is not appropriate for these contracts, revenue is recognized using a cost-to-cost input method. Fees for contracted landscape maintenance services are typically billed on an equal monthly basis. Fees for fixed fee snow removal services are typically billed on an equal monthly basis during snow season, while fees for time and material or other activity-based snow removal services are typically billed as the services are performed. Fees for enhancement services are typically billed as the services are performed.

Development Services

Development Services revenues are generated primarily through landscape architecture and development services. These revenues are primarily recognized over time using the cost-to-cost input method, measured by the percentage of cost incurred to date to the estimated total cost for each contract, which we believe to be the best measure of progress. The full amount of anticipated losses on contracts is recorded as soon as such losses can be estimated. These losses are immaterial to current and historical operations. Changes in job performance, job conditions, and estimated profitability, including final contract settlements, may result in revisions to costs and revenue and are recognized in the period in which the revisions are determined.

Disaggregation of revenue

The following table presents the Company's reportable segment revenues, disaggregated by revenue type. The Company disaggregates revenue from contracts with customers into major services lines. The Company has determined that disaggregating revenue into these categories depicts how the nature, amount, timing, and uncertainty of revenue and cash flows are affected by economic factors. As noted in the business segment reporting information in Note 12 "Segments", the Company's reportable segments are Maintenance Services and Development Services.

Remaining Performance Obligations

Remaining performance obligations represent the estimated revenue expected to be recognized in the future related to performance obligations which are fully or partially unsatisfied at the end of the period.

As of June 30, 2026, the estimated future revenues for remaining performance obligations that are part of a contract that has an original expected duration of greater than one year was approximately \$446.3. The Company expects to recognize revenue on 54% of the remaining performance obligations over the next 12 months and an additional 46% thereafter.

Contract Assets and Liabilities

When a contract results in revenue being recognized in excess of the amount the Company has invoiced or has the right to invoice the customer, a contract asset is recognized. Contract assets are transferred to Accounts receivable, net when the rights to the consideration become unconditional. Contract assets are presented as Unbilled revenue on the Consolidated Balance Sheets.

There were \$114.6 of amounts billed and \$112.6 of additions to our unbilled revenue balance during the nine month period ended June 30, 2026.

Contract liabilities consist of payments received from customers, or such consideration that is contractually due, in advance of providing the product or performing services such that control has not passed to the customer. Contract liabilities are presented as Deferred revenue on the Consolidated Balance Sheets.

Practical Expedients and Exemptions

The Company offers certain interest-free contracts to customers where payments are received over a period not exceeding one year. Additionally, certain Maintenance Services and Development Services customers may pay in advance for services. The Company does not adjust the promised amount of consideration for the effects of these financing components. At contract inception, the period of time between the performance of services and the customer payment is one year or less.

As permitted under the practical expedient available under ASU No. 2014-09, the Company does not disclose the value of unsatisfied performance obligations for (i) contracts with an original expected length of one year or less, (ii) contracts with variable consideration that is allocated entirely to unsatisfied performance obligations or to a wholly unsatisfied promise accounted for under the series guidance and (iii) contracts for which the Company recognizes revenue at the amount which we have the right to invoice for services performed.

First Lien credit facility term loans and Series B Term Loan due 2033

On December 18, 2013, the Company and a group of financial institutions entered into a credit agreement (the "Credit Agreement"). The Credit Agreement consisted of seven-year \$1,460.0 term loans and a five-year \$210.0 revolving credit facility. All amounts outstanding under the Credit Agreement are collateralized by substantially all of the assets of the Company. The Credit Agreement, as amended, provides for: (i) a \$1,200.0 seven-year term loan (the "Series B Term Loan") and (ii) a \$300.0 five-year revolving credit facility (the "Revolving Credit Facility"). There were no debt repayments for the Series B Term Loan for the three and nine months ended June 30, 2026 and 2025, respectively.

On August 28, 2023, the Company voluntarily repaid \$450.0 of the amount outstanding under the Credit Agreement.

On January 29, 2025, the Company entered into Amendment No. 9 to the Credit Agreement (the "Ninth Credit Agreement Amendment"). Under the Ninth Credit Agreement Amendment, the existing Series B Term Loan were amended to bear interest at a rate per annum based on a secured overnight funding rate ("Term SOFR"), plus a margin of 2.00% or a base rate ("ABR") plus a margin of 1.00%, subject to SOFR and ABR floors of 0.50% and 1.50%, respectively.

On June 17, 2026, the Company entered into Amendment No. 11 to the Credit Agreement (the "Eleventh Credit Agreement Amendment"). Under the Eleventh Credit Agreement Amendment, the existing Series B Term Loans were amended to extend the maturity date through June 17, 2033. As a result of the repayment of the amounts outstanding under the Company's Amended Credit Agreement, the Company recorded a loss on debt extinguishment of \$9.7 due to accelerated amortization of deferred financing fees and original issue discount included in the Other (expense) income line of the Consolidated Statements of Operations. An original issue discount of \$2.0 was incurred when the company entered into the Eleventh Credit Agreement Amendment and is being amortized using the effective interest method over the life of the debt, resulting in an effective yield of 5.66%. The Eleventh Credit Agreement Amendment has required amortization debt repayments that are due in quarterly installments of 0.25% of the original principal balance of the Series B Term Loans of \$738.0.

Revolving credit facility

On May 4, 2026, the Company entered into Amendment No. 10 to the Credit Agreement (the "Tenth Credit Agreement Amendment"). The Tenth Credit Agreement Amendment amended certain terms of the Revolving Credit Facility. The Revolving Credit Facility matures on April 22, 2031 and bears interest at a rate per annum of Term SOFR plus a margin ranging from 1.75% to 2.25% or ABR plus a margin ranging from 0.75% to 1.25% subject to SOFR and ABR floors of 0.0% and 1.0%, respectively, with the margin on the Revolving Credit Facility determined based on the Company's first lien net leverage ratio. As a result of the repayment of the amounts outstanding under the Amended Credit Agreement, the Company recorded a loss on debt extinguishment of \$0.1 due to the acceleration of deferred financing fees included in the Other (expense) income line on the Consolidated Statements of Operations. There were no borrowings or repayments under the facility during the three and nine months ended June 30, 2026 and 2025. The Company had no letters of credit issued and outstanding as of June 30, 2026 and September 30, 2025.

Receivables financing agreement

On April 28, 2017, the Company, through a wholly-owned subsidiary, entered into a receivables financing agreement (the "Receivables Financing Agreement").

On June 27, 2024, the Company, through a wholly-owned subsidiary, entered into the Fifth Amendment to the Receivables Financing Agreement (the "Fifth Amendment"). The Fifth Amendment increased the borrowing capacity to \$325.0, and (iii) established a swingline facility of up to \$50.0.

On June 12, 2026, the Company, through a wholly-owned subsidiary, entered into the Sixth Amendment to the Receivables Financing Agreement (the "Sixth Amendment"). Under the terms of the Sixth Amendment, the Receivables Financing Agreement was amended to extend the term through June 12, 2029.

All amounts outstanding under the Receivables Financing Agreement are collateralized by substantially all of the accounts receivable and unbilled revenue of the Company. During the nine months ended June 30, 2026 the Company borrowed \$105.1 against the capacity and voluntarily repaid \$13.0. During the nine months ended June 30, 2025 the Company borrowed \$14.5 against the capacity and voluntarily repaid \$27.9. The Company had \$89.9 of letters of credit issued and outstanding as of June 30, 2026 and \$82.3 of letters of credit issued and outstanding as of September 30, 2025.

8. Fair Value Measurements and Derivative Instruments

Fair value is defined as the price at which an orderly transaction to sell an asset or to transfer a liability would take place between market participants at the measurement date under current market conditions (that is, an exit price at the measurement date from the perspective of a market participant that holds the asset or owes the liability).

The carrying amounts shown for the Company's cash and cash equivalents, restricted cash, accounts receivable and accounts payable approximate fair value due to the short-term maturity of those instruments. The valuation is based on settlements of similar financial instruments all of which are short-term in nature and are generally settled at or near cost.

Investments held in Rabbi Trust

A non-qualified deferred compensation plan is available to certain executives. Under this plan, participants may elect to defer up to 70% of their compensation. The Company invests the deferrals in participant-selected diversified investments that are held in a Rabbi Trust and which are classified within Other assets on the Consolidated Balance Sheets. The fair value of the investments held in the Rabbi Trust is based on the quoted market prices of the underlying mutual fund investments. These investments are based on the participants' selected investments, which represent the underlying liabilities to the participants in the non-qualified deferred compensation plan. Gains and losses on these investments are included in Other expense (income) on the Consolidated Statements of Operations.

Derivatives

The Company's objective in entering into derivative transactions is to manage its exposure to interest rate movements associated with its variable rate debt and changes in fuel prices. The Company recognizes derivatives as either assets or liabilities on the balance sheet and measures those instruments at fair value. The fair values of the derivative financial instruments are determined using widely accepted valuation techniques including discounted cash flow analysis based on the expected cash flows of each derivative. Although the Company has determined that the significant inputs, such as interest yield curve and discount rate, used to value its derivatives fall within Level 2 of the fair value hierarchy, the credit valuation adjustments associated with the Company's counterparties and its own credit risk utilize Level 3 inputs, such as estimates of current credit spreads to evaluate the likelihood of default by itself and its counterparties. However, as of June 30, 2026 and September 30, 2025, the Company assessed the significance of the impact of the credit valuation adjustments on the overall valuation of its derivative positions and determined that the credit valuation adjustments were not significant to the overall valuation of its derivatives. As a result, the Company has determined that its derivative valuations in their entirety are classified in Level 2 of the fair value hierarchy.

Hedging Activities

As of June 30, 2026 and September 30, 2025, the Company's outstanding derivatives qualified as cash flow hedges. The Company assesses whether derivatives used in hedging transactions are "highly effective" in offsetting changes in the cash flow of the hedged forecasted transactions. Regression analysis is used for the hedge relationships and high effectiveness is achieved when a statistically valid relationship reflects a high degree of offset and correlation between the fair values of the derivative and the hedged forecasted transaction. The entire change in the fair value for highly effective derivatives is reported in Other comprehensive income (loss) and subsequently reclassified into Interest expense, net (in the case of interest rate contracts) and Cost of services provided (in the case of fuel hedge contracts) in the Consolidated Statements of Operations when the hedged item affects earnings. If the hedged forecasted transaction is no longer probable of occurring, then the amount recognized in Accumulated other comprehensive income (loss) is released to earnings. Cash flows from the derivatives are classified in the same category as the cash flows from the underlying hedged transaction.

Interest Rate Contracts

The Company has exposures to variability in interest rates associated with its variable interest rate debt, which includes the Series B Term Loan. As such, the Company has entered into interest rate contracts to help manage interest rate exposure by economically converting a portion of its variable-rate debt to fixed-rate debt. In January 2023, the Company entered into an interest rate swap agreement with a notional amount of \$500.0 and an interest rate collar agreement with a notional amount of \$500.0, each effective for the period January 31, 2023 through January 31, 2028.

On August 28, 2023, the Company terminated \$400.0 of the notional amount of its outstanding interest rate collar agreement.

The notional amount of interest rate contracts was \$600.0 at June 30, 2026 and September 30, 2025. As of June 30, 2026, net deferred gain on the interest rate contracts of \$2.2, net of taxes, is expected to be recognized in Interest expense over the next 12 months.

Fuel Contracts

The Company has exposures to variability in fuel pricing associated with its purchase and usage of fuel during the ordinary course of business operating a large fleet of vehicles and equipment. As such, the Company has entered into gasoline hedge contracts to help reduce its exposure to volatility in the fuel markets. In October 2025, the Company entered into a fuel swap agreement with a notional volume of 3.0 million gallons covering the period of April 2026 through March 2027. In March 2026, the Company entered into two fuel swap agreements with a combined notional amount 2.0 million gallons covering the period of May 2026 through April 2027. The net deferred gain on the fuel swaps as of June 30, 2026 was \$0.6, net of taxes, and is expected to be recognized in Cost of services provided over the next 10 months.

The decrease in the effective tax rate for the three months ended June 30, 2026, when compared to the three months ended June 30, 2025, is primarily attributable to the unfavorable federal return to provision adjustment being recorded in the third quarter of FY25.

The relative amounts of the year-to-date shortfall compared with the year-to-date pre-tax loss for the nine months ended June 30, 2026 makes up a larger positive effect on the effective tax rate than the amount of windfall compared to year-to-date pretax income for the nine months ended June 30, 2025.

10. Equity-Based Compensation

Amended and Restated 2018 Omnibus Incentive Plan

On June 28, 2018 (and as amended and restated on March 10, 2020 and March 5, 2024), in connection with the IPO, the Company's Board of Directors adopted, and its stockholders approved, the BrightView Holdings, Inc. 2018 Omnibus Incentive Plan (the "2018 Omnibus Incentive Plan"). The total number of shares of common stock that may be issued under the 2018 Omnibus Incentive Plan is 24,650,000. Under the 2018 Omnibus Incentive Plan, the Company may grant stock options, stock appreciation rights, restricted stock, other equity-based awards and other cash-based awards to employees, directors, officers, consultants and advisors.

2023 Employment Inducement Incentive Award Plan

On September 11, 2023, the Company adopted the BrightView Holdings, Inc. 2023 Employment Inducement Incentive Award Plan (the "Inducement Plan"). Pursuant to the Inducement Plan, the Company may grant equity incentive compensation as a material inducement for certain individuals to commence employment with the Company. A total of 1,750,000 shares of common stock were reserved for grant under the Inducement Plan. Awards granted under the Inducement Plan may be in the form of non-qualified stock options, stock appreciation rights, restricted stock awards, restricted stock units, unrestricted stock awards, dividend equivalent rights and other equity-based awards, or any combination of those awards.

During the nine month period ended June 30, 2026, the Company issued 499,000 performance stock units ("PSUs") at a weighted average distribution price of \$12.76 per share and a weighted average grant date fair value of \$12.76 per share, which cliff vest at the end of the three-year performance period. The number of the PSUs that vest upon completion of the performance period can range from 0% to 200% of the original grant, subject to certain limitations, contingent upon performance conditions. The performance condition metrics are the Company's three-year average Adjusted EBITDA margin, return on invested capital, and compound annual growth rate of the Company's land organic revenue. The fair value of these awards is determined based on the trading price of the company's common shares on the date of grant. Expected non-cash equity-based compensation expense associated with the grant will be approximately \$5.4 over the requisite service period. During the nine month period ended June 30, 2026, 42,000 PSUs were forfeited.

Equity-Based Compensation Expense

The Company recognizes equity-based compensation expense using the estimated fair value as of the grant date over the requisite service or performance period applicable to the grant. Estimates of future forfeitures are made at the date of grant and revised, if necessary, in subsequent periods if actual forfeitures differ from those estimates.

The Company recognized \$4.5 and \$4.6 in equity-based compensation expense for the three months ended June 30, 2026 and 2025, respectively, included in Selling, general and administrative expense in the accompanying Consolidated Statements of Operations. The Company recognized \$13.0 and \$13.6 in equity-based compensation expense for the nine months ended June 30, 2026 and 2025, respectively, included in Selling, general and administrative expense in the accompanying Consolidated Statements of Operations. The resulting charges increased Additional paid in capital by the same amount for each applicable period. Total unrecognized compensation cost was \$28.0 and \$24.3 as of June 30, 2026 and September 30, 2025, respectively, which is expected to be recognized over a weighted average period of 1.2 years as of June 30, 2026 and September 30, 2025, respectively.

2018 Employee Stock Purchase Plan

The Company's Stockholders have approved the Company's 2018 Employee Stock Purchase Plan, (the "ESPP"). A total of 2,100,000 shares of the Company's common stock were made available for sale under the Company's 2018 Employee Stock Purchase Plan, of which 103,000 were issued on November 17, 2025, and 73,000 were issued on November 18, 2024. An additional portion thereof is expected to be issued in November 2026.

11. Commitments and Contingencies

Risk Management

The Company carries general liability, auto liability, workers' compensation, and employee health care insurance policies. In addition, the Company carries other reasonable and customary insurance policies for a Company of our size and scope, as well as umbrella liability insurance policies to cover claims over the liability limits contained in the primary policies. The Company's insurance programs, for workers' compensation, general liability, auto liability and employee health care for certain employees contain self-insured retention amounts, deductibles and other coverage limits ("self-insured liability"). Claims that are not self-insured as well as claims in excess of the self-insured liability amounts are insured. The Company uses estimates in the determination of the required reserves. These estimates are based upon calculations performed by third-party actuaries, as well as examination of historical trends and industry claims experience. The Company's reserve for unpaid and incurred but not reported claims under these programs at June 30, 2026 was \$184.4, of which \$53.2 was classified in current liabilities and \$131.2 was classified in non-current liabilities in the accompanying unaudited Consolidated Balance Sheet. The Company's reserve for unpaid and incurred but not reported claims under these programs at September 30, 2025 was \$175.1, of which \$52.3 was classified in current liabilities and \$122.8 was classified in non-current liabilities in the accompanying Consolidated Balance Sheet. While the ultimate amount of these claims is dependent on future developments, in management's opinion, recorded reserves are adequate to cover these claims. The Company's reserve for unpaid and incurred but not reported claims at June 30, 2026 includes \$33.2 related to claims recoverable from third-party insurance carriers. Corresponding assets of \$9.3 and \$23.9 are recorded at June 30, 2026, as Other current assets and Other assets, respectively. The Company's reserve for unpaid and incurred but not reported claims at September 30, 2025 includes \$24.2 related to claims recoverable from third-party insurance carriers. Corresponding assets of \$7.0 and \$17.2 were recorded at September 30, 2025, as Other current assets and Other assets, respectively.

Litigation Contingency

From time to time, the Company is subject to legal proceedings and claims in the ordinary course of its business, principally claims made alleging injuries (including vehicle and general liability matters as well as workers' compensation and property casualty claims). Such claims, even if lacking merit, can result in expenditures of significant financial and managerial resources. In the ordinary course of its business, the Company is also subject to investigations or claims involving current and/or former employees and disputes involving commercial and regulatory matters. Regulatory matters include, among other things, audits and reviews of local and federal tax compliance, safety and employment practices, and environmental matters. Although the process of resolving regulatory matters and claims through litigation and other means is inherently uncertain, the Company is not aware of any such matter, legal proceeding or claim that it believes will have, individually or in the aggregate, a material effect on the Company, its financial condition, and results of operations or cash flows. For all legal matters, an estimated liability is established in accordance with the loss contingencies accounting guidance. This estimated liability is included in Accrued expenses and other current liabilities in the accompanying Consolidated Balance Sheets.

12. Segments

The operations of the Company are conducted through two operating segments: Maintenance Services and Development Services, which are also its reportable segments.

Maintenance Services primarily consists of recurring landscape maintenance services and snow removal services as well as supplemental landscape enhancement services.

Development Services primarily consists of landscape architecture and development services for new construction and large scale redesign projects.

The operating segments identified above are determined based on the services provided, and they reflect the manner in which operating results are regularly reviewed by the Chief Operating Decision Maker ("CODM") to allocate resources and assess

performance. The CODM is the Company's Chief Executive Officer. The CODM uses Adjusted EBITDA as the measure of profitability to evaluate the performance of the Company's operating segments. The CODM utilizes the identified metrics as part of the annual budgeting and forecasting process and during the monthly business reviews when making decisions about the allocation of resources.

As part of the CODM's review of operating results, the CODM considers direct costs, which include direct labor and materials, as a significant segment expense. The CODM evaluates segment performance each period against historical results factoring in macroeconomic factors such as direct labor and materials to assess segment performance.

The accounting policies of the segments are the same as those described in Note 2 "Summary of Significant Accounting Policies" in the notes to our consolidated financial statements in the Annual Report on Form 10-K for the fiscal year ended September 30, 2025. Eliminations represent eliminations of intersegment revenues. Intersegment revenue transactions are recorded at current market price. The Company does not currently provide asset information by segment, as this information is not used by management when allocating resources or evaluating performance.

13. Mezzanine Equity

Series A Convertible Preferred Stock

On August 28, 2023 (the “Original Issuance Date”), BrightView Holdings, Inc. entered into an Investment Agreement with each of Birch Equity Holdings, LP, a Delaware limited partnership, and Birch-OR Equity Holdings, LLC, a Delaware limited liability company (collectively, the “Investors”), pursuant to which the Company issued and sold, in a private placement, an aggregate of 500,000 shares of the Company’s Series A Convertible Preferred Stock, par value \$0.01 per share (the “Series A Preferred Stock”), for an aggregate purchase price of \$500.0 (the “Issuance”), excluding issuance costs.

On June 11, 2026 the Company declared a cash dividend of \$8.9 in aggregate on the Series A Preferred Stock, which was paid to the Investors on July 1, 2026. The accrued dividend is presented within Accrued expense and other current liabilities on the Consolidated Balance Sheet as of June 30, 2026.

14. Earnings (Loss) Per Share of Common Stock

The Company calculates basic and diluted (loss) earnings per common share using the two-class method. The two-class method is an allocation formula that determines net (loss) income per common share for each share of common stock and Series A Convertible Preferred Stock, a participating security, according to dividends declared and participation rights in undistributed earnings. Under this method, all earnings (distributed and undistributed) are allocated to common shares and Series A Convertible Preferred Stock based on their respective rights to receive dividends. The holders of the Series A Convertible Preferred Stock do not participate in losses. The holders of Series A Convertible Preferred Stock participate in cash dividends that the Company pays on its common stock on an as-converted basis. Diluted net (loss) income per common share is computed based on the weighted average number of shares of common stock outstanding during each period, plus potential common shares considered outstanding during the period, as long as the inclusion of such awards is not antidilutive. Potential common shares consist of unvested and unexercised stock compensation awards and the Series A Convertible Preferred Stock, using the more dilutive of either the two-class method or if-converted stock method.

Item 2. Management’s Discussion and Analysis of Financial Condition and Results of Operations.

The following discussion and analysis supplements our management’s discussion and analysis for the year ended September 30, 2025 as contained in our Annual Report on Form 10-K filed with the Securities and Exchange Commission on November 19, 2025, and presumes that readers have read or have access to such discussion and analysis. The following discussion and analysis should also be read together with the unaudited consolidated financial statements and the related notes thereto included elsewhere in this Quarterly Report on Form 10-Q. This discussion contains forward-looking statements that reflect our plans and strategy for our business, and involve risks and uncertainties. You should review the “Risk Factors” section of our Annual Report on Form 10-K for the fiscal year ended September 30, 2025, as updated by subsequent filings with the Securities and Exchange Commission, for a discussion of important factors that could cause actual results to differ materially from the results described in or implied by the forward-looking statements contained in the following discussion and analysis. You should carefully read “Special Note Regarding Forward-Looking Statements” in this Quarterly Report on Form 10-Q.

Overview

Our Company

We are the largest provider of commercial landscaping services in the United States, with revenues approximately 4 times those of our next largest commercial landscaping competitor. We provide commercial landscaping services ranging from landscape maintenance and enhancements to tree care and landscape development. We operate through a differentiated and integrated national service model which systematically delivers services at the local level by combining our network of over 265 branches with a qualified service partner network. Our branch delivery model underpins our position as a single-source end-to-end landscaping solution provider to our diverse customer base at the national, regional and local levels, which we believe represents a significant competitive advantage. We believe our commercial customer base understands the financial and reputational risk associated with inadequate landscape maintenance and considers our services to be essential and non-discretionary.

Our Segments

We report our results of operations through two reportable segments: Maintenance Services and Development Services. We serve a geographically diverse set of customers through our strategically located network of branches in 36 U.S. states.

Maintenance Services

Our Maintenance Services segment delivers a full suite of recurring commercial landscaping services in both evergreen and seasonal markets, ranging from mowing, gardening, mulching and snow removal, to more horticulturally advanced services, such as water management, irrigation maintenance, tree care, and golf course maintenance. In addition to contracted maintenance services, we also have a strong track record of providing value-added landscape enhancements. We primarily self-perform our maintenance services through our national branch network, which are route-based in nature. Our maintenance services customers include Fortune 500 corporate campuses and commercial properties, HOAs, public parks, leading international hotels and resorts, airport authorities, municipalities, hospitals and other healthcare facilities, educational institutions, restaurants and retail, and golf courses, among others.

Development Services

Through our Development Services segment, we provide landscape architecture and development services for new facilities and significant redesign projects. Specific services include project design and management services, landscape architecture, landscape installation, irrigation installation, tree moving and installation, pool and water features, sports field services, and specialty turf maintenance, among others. Our development services are comprised of sophisticated design, coordination and installation of landscapes at some of the most recognizable corporate, athletic and university complexes and showcase highly visible work that is paramount to our customers’ perception of our brand as a market leader.

In our Development Services business, we are typically hired by general contractors, with whom we maintain strong relationships as a result of our superior technical and project management capabilities. We believe the quality of our work is also well-regarded by our end-customers, some of whom directly request that their general contractors utilize our services when outsourcing their landscape development projects.

Components of Our Revenues and Expenses

Net Service Revenues

Maintenance Services

Our Maintenance Services revenues are generated primarily through landscape maintenance services and snow removal services. Landscape maintenance services that are primarily viewed as non-discretionary, such as lawn care, mowing, gardening, mulching, leaf removal, irrigation and tree care, are provided under recurring annual contracts, which typically range from one to three years in duration and are generally cancellable by the customer with 30-90 days' notice. Snow removal services are provided on either fixed fee based contracts or per occurrence contracts. Both landscape maintenance services and snow removal services can also include enhancement services that represent supplemental maintenance or improvement services generally provided under contracts of short duration related to specific services. Revenue for landscape maintenance and snow removal services under fixed fee models is recognized over time using an output based method. Additionally, a portion of our recurring fixed fee landscape maintenance and snow removal services are recorded under the series guidance. The right to invoice practical expedient, defined within Note 3 "Revenue" to our unaudited consolidated financial statements, is generally applied to revenue related to landscape maintenance and snow removal services performed in relation to per occurrence contracts as well as enhancement services. When use of the practical expedient is not appropriate for these contracts, revenue is recognized using a cost-to-cost input method. Fees for contracted landscape maintenance services are typically billed on an equal monthly basis. Fees for fixed fee snow removal services are typically billed on an equal monthly basis during snow season, while fees for time and material or other activity-based snow removal services are typically billed as the services are performed. Fees for enhancement services are typically billed as the services are performed.

Development Services

For Development Services, revenue is primarily recognized over time using the cost-to-cost input method, measured by the percentage of cost incurred to date to the estimated total cost for each contract, which we believe to be the best measure of progress. The full amount of anticipated losses on contracts is recorded as soon as such losses can be estimated. These losses have been immaterial to current and historical operations. Changes in job performance, job conditions and estimated profitability, including final contract settlements, may result in revisions to costs and revenue and are recognized in the period in which the revisions are determined.

Expenses

Cost of Services Provided

Cost of services provided is comprised of direct costs we incur associated with our operations during a period and includes employee costs, subcontractor costs, purchased materials, and operating equipment and vehicle costs. Employee costs consist of wages and other labor-related expenses, including benefits, self insurance and healthcare costs, for those employees involved in delivering our services. Subcontractor costs consist of costs relating to our qualified service partner network in our Maintenance Services segment and subcontractors we engage from time to time in our Development Services segment. When our use of subcontractors increases, we may experience incrementally higher costs of services provided. Operating equipment and vehicle costs primarily consist of depreciation related to branch operating equipment and vehicles and related fuel expenses. A large component of our costs are variable, such as labor, subcontractor expense, fuel and materials.

Selling, General and Administrative Expense

Selling, general and administrative expense consists of costs incurred related to compensation, benefits, and self insurance for management, sales and administrative personnel, equity-based compensation, branch and office rent and facility operating costs, depreciation expense related to branch and office locations, as well as professional fees, software costs and other miscellaneous expenses. Corporate expenses, including corporate executive compensation, finance, legal and information technology, are included in consolidated Selling, general and administrative expense.

Amortization Expense

Amortization expense consists of the periodic amortization of intangible assets and customer relationships. The corresponding intangible assets were originally recognized in connection with the KKR and ValleyCrest acquisitions, as well as from subsequent acquisitions.

Other Expense (Income)

Other expense (income) consists primarily of losses on debt extinguishment as well as investment gains and losses related to investments held in Rabbi Trust.

Interest Expense, Net

Interest expense, net consists primarily of interest expense related to our long-term debt as well as interest income related to our cash and cash equivalents. See Note 7 “Long-term Debt” in the unaudited consolidated financial statements included under Part I, Item 1, “Financial Statements”.

Income Tax Expense (Benefit)

Income tax expense (benefit) includes U.S. federal, state and local income taxes. Our effective tax rate differs from the statutory U.S. income tax rate due to the effect of state and local income taxes, tax credits and certain nondeductible expenses. Our effective tax rate may vary from quarter to quarter based on recurring and nonrecurring factors including, but not limited to, the geographical distribution of our pre-tax earnings, changes in the tax rates of different jurisdictions, the availability of tax credits and nondeductible items. Changes in judgment due to the evaluation of new information resulting in the recognition, derecognition or remeasurement of a tax position taken in a prior annual period are recognized separately in the period of the change.

Trends and Other Factors Affecting Our Business

Various trends and other factors affect or have affected our operating results, including:

Seasonality

Our services, particularly in our Maintenance Services segment, have seasonal variability such as increased mulching, flower planting and intensive mowing in the spring, leaf removal and cleanup work in the fall, snow removal services in the winter and potentially minimal mowing during drier summer months. This can drive fluctuations in revenue, costs and cash flows for interim periods.

We have a significant presence in geographies that have a year-round growing season, which we refer to as our evergreen markets. Such markets require landscape maintenance services twelve months per year. In markets that do not have a year-round growing season, which we refer to as our seasonal markets, the demand for our landscape maintenance services decreases during the winter months. Typically, our revenues and net income have been higher in the spring and summer seasons, which correspond with our third and fourth fiscal quarters of our fiscal year ending September 30. The lower level of activity in seasonal markets during our first and second fiscal quarters is partially offset by revenue from our snow removal services. Such seasonality causes our results of operations to vary from quarter to quarter.

One BrightView Initiative

In fiscal year 2024, the Company launched its One BrightView initiative. The One BrightView initiative represents a cultural change and encapsulates the Company’s effort to refocus our core service lines and position ourselves for long-term profitable growth by streamlining our operating structure, leveraging our size and scale, and becoming the employer of choice. As part of the initiative, the Company introduced transformational changes designed to unite the organization as one comprehensive team and drive a renewed focus on the Company's profitable core businesses. Transformation costs associated with the implementation of the One BrightView initiative are reflected in the fiscal 2025 results. The actions taken under the One BrightView initiative have resulted in improved customer and employee retention and contributed to sustainable improved profitability.

Weather Conditions

Weather may impact the timing of performance of landscape maintenance and enhancement services and progress on development projects from quarter to quarter. For example, snow events in the winter, hurricane-related cleanup in the summer and fall, and the effects of abnormally high rainfall or drought in a given market may impact our services. These less predictable weather patterns can impact both our revenues and our costs, especially from quarter to quarter, but also from year to year in some cases. Extreme weather events such as hurricanes and tropical storms can result in a positive impact to our business in the form of increased enhancement services revenues related to cleanup and other services. However, such weather events may also negatively impact our ability to deliver

our contracted services or impact the timing of performance. In our seasonal markets, the performance of our snow removal services is correlated with the amount of snowfall and number of snowfall events in a given season.

Acquisitions

In addition to our organic growth, we have grown, and expect to continue to grow, our business through acquisitions in an effort to better service our existing customers and attract new customers. These acquisitions focused on increasing our density and leadership positions in existing local markets, entering into attractive new geographic markets and expanding our portfolio of landscape enhancement services and improving technical capabilities in specialized services.

As we move forward, we will selectively pursue accretive acquisitions that will focus on increasing market density to build upon our existing footprint in strategic markets, entering new attractive geographies (i.e. 'greenfield'), and increasing service line density and entering adjacent service lines to provide a robust and consistent suite of services to our customers. Under this renewed strategy, we believe we are the acquirer of choice in the highly fragmented commercial landscaping industry because we offer the ability to leverage our significant size and scale to drive accretive acquisitions, quickly and seamlessly integrate new businesses into ours and provide stable and potentially expanding career opportunities for employees of acquired businesses.

In accordance with GAAP, the results of the acquisitions we have completed are reflected in our consolidated financial statements from the date of acquisition. We incur transaction costs in connection with identifying and completing acquisitions and ongoing integration costs as we integrate acquired companies and seek to achieve synergies. Integration costs vary based on factors specific to each acquisition, such costs are primarily comprised of one-time employee retention costs, employee onboarding and training costs, and fleet and uniform rebranding costs. We typically anticipate integration costs to represent approximately 7%-9% of the acquisition price, and to be incurred within 12 months of acquisition completion.

Goodwill

Goodwill represents the excess of the purchase price over the fair values of the underlying net assets acquired in an acquisition. Goodwill is not amortized, but rather is tested annually for impairment, or more frequently if events or changes in circumstances indicate that the carrying amount of the asset may not be recoverable. We test goodwill for impairment annually in the fourth quarter of each year using data as of July 1 of that year.

Goodwill is allocated to, and evaluated for impairment at our two identified reporting units. Goodwill is tested for impairment by either performing a qualitative evaluation or a quantitative test. The qualitative evaluation is an assessment of factors to determine whether it is more likely than not that a reporting unit's fair value is less than its carrying amount. We may elect not to perform the qualitative assessment for some or all reporting units and perform the quantitative impairment test. The quantitative goodwill impairment test requires us to compare the carrying value of the reporting unit's net assets to the fair value of the reporting unit. The Company determined fair values of each of the reporting units using a combination of the income and market multiple approaches. The estimates used in each approach include significant management assumptions, including valuation multiples of selected guideline public companies, long-term future growth rates, operating margins, and discount rates.

If the fair value exceeds the carrying value, no further evaluation is required, and no impairment loss is recognized. If the carrying amount of a reporting unit, including goodwill, exceeds the estimated fair value, the excess of the carrying value over the fair value is recorded as an impairment loss, the amount of which would not exceed the total amount of goodwill allocated to the reporting unit.

Our methodology for estimating the fair value of our reporting units utilizes a combination of the market and income approaches. The market approach is based on the guideline public company method, which measures the value of the reporting unit through applying valuation multiples of selected guideline public companies to the reporting unit's key operating metrics. The income approach is based on the Discounted Cash Flow ("DCF") method, which is based on the present value of future cash flows. The principal assumptions utilized in the DCF methodology include long-term future growth rates, operating margins, and discount rates. There can be no assurance that our estimates and assumptions regarding forecasted cash flow, long-term future growth rates and operating margins made for purposes of the annual goodwill impairment test will prove to be accurate predictions of the future. We believe the current assumptions and estimates utilized under each approach are both reasonable and appropriate.

Based on our most recent annual analysis as of July 1, 2025, the fair values for all identified reporting units exceeded the carrying values, and therefore no indicators of impairment existed for the reporting units; however, the fair value of the Maintenance reporting unit exceeded the carrying value by 15.4%. Since the Maintenance reporting unit fair value did not substantially exceed the carrying value, we may be at risk for an impairment loss in the future if interest rates and market conditions continue to trend unfavorably or if our forecasts assumed in the fair value calculation are not realized. As of June 30, 2026, there was \$1,797.7 million of goodwill recorded related to the Maintenance reporting unit.

Industry and Economic Conditions

We believe the non-discretionary nature of our landscape maintenance services provides us with a fairly predictable recurring revenue model. The perennial nature of the landscape maintenance service sector, as well as its wide range of end users, minimizes the impact of a broad or sector-specific downturn. However, in connection with our enhancement services and development services, when demand for commercial construction declines, demand for landscape enhancement services and development projects may decline. When commercial construction activity rises, demand for landscape enhancement services to maintain green space may also increase. This is especially true for new developments in which green space tends to play an increasingly important role. Economic conditions, including rising inflation and fuel prices, as well as rising interest rates and tariffs, have impacted and may further impact our costs and expenses. Additionally, fluctuations in labor markets, may impact our ability to identify, hire and retain employees.

Regulatory Impacts

On July 4, 2025, President Trump signed into law the One Big Beautiful Bill Act (“OBBBA”) that includes tax reform provisions that amend, eliminate and extend tax rules under the Inflation Reduction Act and Tax Cuts and Jobs Act. The most significant impact to the Company of the OBBBA at this time is the permanent reinstatement of bonus depreciation on qualified property and modifications to the calculation for excess business interest expense limitation under 163(j). The impact defers the payment of a significant portion of our current federal tax liability for several years. However, because our tax provision is based on both the current and deferred tax, the overall impact to our income statement is immaterial.

Three Months Ended June 30, 2026 compared to Three Months Ended June 30, 2025

Net Service Revenues

Net service revenues for the three months ended June 30, 2026 increased \$9.3 million, or 1.3%, to \$717.6 million, from \$708.3 million in the 2025 period. The increase was driven by an increase in Maintenance Services revenues of \$9.1 million.

Gross Profit

Gross profit for the three months ended June 30, 2026 decreased \$19.0 million, or 11.1%, to \$151.9 million, from \$170.9 million in the 2025 period. Gross margin decreased 290 basis points, to 21.2%, in the three months ended June 30, 2026, from 24.1% in the comparable 2025 period. The decrease in gross profit was primarily driven by a non-routine self-insurance adjustment and increased depreciation expense, partially offset by the increase in revenues described above.

Selling, General and Administrative Expense

Selling, general and administrative expense for the three months ended June 30, 2026 increased \$8.3 million, or 7.8%, to \$114.5 million, from \$106.2 million in the 2025 period. As a percentage of revenue, Selling, general and administrative expense increased 100 basis points for the three months ended June 30, 2026 to 16.0% from 15.0% in the 2025 period. The increase was primarily driven by non-routine self-insurance adjustment combined with increased selling costs driven by the Company's investment in new sellers, partially offset by a decrease in non-seller compensation costs.

Amortization Expense

Amortization expense for the three months ended June 30, 2026 decreased \$2.0 million, or 28.2%, to \$5.1 million from \$7.1 million in the 2025 period. The decrease was principally due the decrease in the amortization of intangible assets, based on the pattern consistent with expected future cash flows calculated at the time the assets were acquired.

Other Expense (Income)

Other expense was \$9.0 million for the three months ended June 30, 2026 compared to Other income of \$0.7 million in the 2025 period. The increase of \$9.7 was driven by the losses on the extinguishment of debt in connection with the Tenth Credit Agreement Amendment and the Eleventh Credit Agreement Amendment in fiscal 2026.

Interest Expense, Net

Interest expense, net for the three months ended June 30, 2026 increased \$1.5 million, or 11.2%, to \$14.9 million from \$13.4 million in the 2025 period. The increase was driven by an increase in the Company's outstanding debt balance, a decrease in interest income associated with the Company's cash and cash equivalents balance, an increase in interest expense due to the impact of interest rate derivative contracts, and an increase in finance lease interest. These were partially offset by lower interest expense caused by the decrease in interest rates as a result of the repricing of our Series B Term Loans in fiscal 2025.

Income Tax Expense

For the three months ended June 30, 2026, Income tax expense was \$2.3 million compared to \$12.6 million in the 2025 period. The decrease was primarily attributable to the change in Income before income taxes.

Net Income

For the three months ended June 30, 2026, Net income was \$6.1 million compared to a Net income of \$32.3 million in the 2025 period due to the changes noted above. Net income as a percentage of revenue was 0.9% for the three months ended June 30, 2026 compared to 4.6% for the three months ended June 30, 2025.

Adjusted EBITDA

Adjusted EBITDA decreased \$17.1 million for the three months ended June 30, 2026, to \$96.1 million, from \$113.2 million in the 2025 period. Adjusted EBITDA as a percentage of revenue was 13.4% and 16.0% for the three months ended June 30, 2026 and 2025, respectively. The decrease in Adjusted EBITDA was primarily driven by a decrease of \$18.7 million, or 22.9%, in Maintenance Services Segment Adjusted EBITDA, partially offset by an increase of \$1.6 million, or 5.1%, in Development Services Segment Adjusted EBITDA, as discussed further below in Segment Results.

Adjusted Net Income

Adjusted Net Income for the three months ended June 30, 2026 decreased \$20.1 million to \$25.4 million, from \$45.5 million in the 2025 period due to the changes noted above.

Nine Months Ended June 30, 2026 compared to Nine Months Ended June 30, 2025

Net Service Revenues

Net service revenues for the nine months ended June 30, 2026 increased \$65.3 million, or 3.3%, to \$2,035.3 million, from \$1,970.0 million in the 2025 period. The increase was driven by an increase in Maintenance Services revenues of \$98.0 million, partially offset by a decrease in Development Services revenues of \$34.3 million.

Gross Profit

Gross profit for the nine months ended June 30, 2026 decreased \$41.3 million, or 9.3%, to \$403.9 million, from \$445.2 million in the 2025 period. Gross margin decreased 280 basis points, to 19.8%, in the nine months ended June 30, 2026, from 22.6% in the comparable 2025 period. The decrease in gross profit was primarily driven by increased depreciation expense and a non-routine self-insurance adjustment, partially offset by the increase in revenues described above.

Selling, General and Administrative Expense

Selling, general and administrative expense for the nine months ended June 30, 2026 increased \$2.4 million, or 0.7%, to \$345.9 million, from \$343.5 million in the 2025 period. As a percentage of revenue, Selling, general and administrative expense decreased 40 basis points for the nine months ended June 30, 2026 to 17.0% from 17.4% in the 2025 period. The increase was primarily driven by a non-routine self-insurance adjustment combined with increased selling costs driven by the Company's investment in new sellers, partially offset by a decrease in non-seller compensation costs.

Amortization Expense

Amortization expense for the nine months ended June 30, 2026 decreased \$5.6 million, or 25.1%, to \$16.7 million from \$22.3 million in the 2025 period. The decrease was principally due to the decrease in the amortization of intangible assets, based on the pattern consistent with expected future cash flows calculated at the time the assets were acquired.

Other Expense

Other expense was \$8.9 million for the nine months ended June 30, 2026 compared to \$0.1 million in the 2025 period. The change of \$8.8 million was driven by the losses on the extinguishment of debt in connection with the Tenth Credit Agreement Amendment and the Eleventh Credit Agreement Amendment in fiscal 2026.

Interest Expense, Net

Interest expense, net for the nine months ended June 30, 2026 increased \$1.8 million, or 4.5%, to \$42.1 million from \$40.3 million in the 2025 period. The increase was driven by an increase in interest expense due to the impact of interest rate derivative contracts, a decrease in interest income associated with the decrease in the Company's cash and cash equivalents balance combined with

an increase in the Company's outstanding debt balance, and an increase in finance lease interest. These were partially offset by lower interest expense caused by the decrease in interest rates as a result of the repricing of our Series B Term Loans in fiscal 2025.

Income Tax (Benefit)

For the nine months ended June 30, 2026, Income tax benefit was \$2.3 million compared to expense of \$10.7 million in the 2025 period. The increase was primarily attributable to the change in Income (loss) before income taxes.

Net Loss (Income)

For the nine months ended June 30, 2026, Net loss was \$7.4 million compared to a Net income of \$28.3 million in the 2025 period due to the changes noted above. Net loss as a percentage of revenue was 0.4% for the nine months ended June 30, 2026 compared to 1.4% for the nine months ended June 30, 2025.

Adjusted EBITDA

Adjusted EBITDA decreased \$10.2 million for the nine months ended June 30, 2026, to \$228.6 million, from \$238.8 million in the 2025 period. Adjusted EBITDA as a percentage of revenue was 11.2% and 12.1% for the nine months ended June 30, 2026 and 2025, respectively. The decrease in Adjusted EBITDA was primarily driven by an decrease of \$5.5 million, or 8.3%, in Development Services Segment Adjusted EBITDA combined with a decrease of \$4.7 million, or 2.7%, in Maintenance Services Segment Adjusted EBITDA, as discussed further below in Segment Results.

Adjusted Net Income

Adjusted Net Income for the nine months ended June 30, 2026 decreased \$36.1 million to \$36.5 million, from \$72.6 million in the 2025 period due to the changes noted above.

Non-GAAP Financial Measures

In addition to our GAAP financial measures, we review various non-GAAP financial measures including Adjusted EBITDA, Adjusted Net Income, Adjusted Earnings per Share ("Adjusted EPS") and Adjusted Free Cash Flow.

We believe that Adjusted EBITDA, Adjusted Net Income and Adjusted EPS are helpful supplemental measures to assist us and investors in evaluating our operating results as they exclude certain items whose fluctuations from period to period do not necessarily correspond to changes in the operations of our business. Adjusted EBITDA represents net income (loss) before interest, taxes, depreciation, amortization and certain non-cash, non-recurring and other adjustment items. Adjusted Net Income is defined as net income (loss) including interest and depreciation and excluding other items used to calculate Adjusted EBITDA and further adjusted for the tax effect of these exclusions and the removal of the discrete tax items. Adjusted EPS is defined as Adjusted Net Income divided by the (i) weighted average number of common shares outstanding used in the calculation of basic earnings per share plus (ii) shares of common stock related to the Series A Preferred Stock on an as-converted basis, assumed to be converted for the entire period. We believe that the adjustments applied in presenting Adjusted EBITDA, Adjusted Net Income and Adjusted EPS are appropriate to provide additional information to investors about certain material non-cash items and about non-recurring items that we do not expect to continue at the same level in the future.

We believe Adjusted Free Cash Flow is a helpful supplemental measure to assist us and investors in evaluating our liquidity. Adjusted Free Cash Flow represents cash flows from operating activities less capital expenditures, net of proceeds from the sale of property and equipment. We believe Adjusted Free Cash Flow is useful to provide additional information to assess our ability to pursue business opportunities and investments and to service our debt. Adjusted Free Cash Flow has limitations as an analytical tool, including that it does not account for our future contractual commitments and excludes investments made to acquire assets under finance leases and required debt service payments.

Adjusted EBITDA, Adjusted Net Income, Adjusted EPS and Adjusted Free Cash Flow are not recognized terms under GAAP and should not be considered as an alternative to net income (loss) as a measure of financial performance or cash flows provided by operating activities as a measure of liquidity, or any other performance measure derived in accordance with GAAP. The presentations of these measures have limitations as analytical tools and should not be considered in isolation, or as a substitute for analysis of our

results as reported under GAAP. Because not all companies use identical calculations, the presentations of these measures may not be comparable to the same or other similarly titled measures of other companies and can differ significantly from company to company.

Set forth below are the reconciliations of net income (loss) to Adjusted EBITDA and Adjusted Net Income, and cash flows from operating activities to Adjusted Free Cash Flow. Adjusted EPS is defined as Adjusted Net Income (shown below) divided by the Adjusted Weighted Average Number of Common Shares Outstanding for the period used in the calculation of basic EPS which is presented in Note 14 “Earnings (Loss) Per Share of Common Stock” in the Notes to our unaudited consolidated financial statements.

Segment Results

We classify our business into two segments: Maintenance Services and Development Services. Our corporate operations are allocated to the segments on a pro rata basis, based on segment revenue.

We evaluate the performance of our segments on Net service revenues, Segment Adjusted EBITDA and Segment Adjusted EBITDA Margin (Segment Adjusted EBITDA as a percentage of Net service revenues). Segment Adjusted EBITDA is indicative of operational performance and ongoing profitability. Our management closely monitors Segment Adjusted EBITDA to evaluate past performance and identify actions required to improve profitability.

Maintenance Services Net Service Revenues

Maintenance Services net service revenues for the three months ended June 30, 2026 increased by \$9.1 million, or 1.8%, from the 2025 period. Commercial Landscaping services increased by \$11.7 million, or 2.3%, and Snow removal services decreased by \$2.5 million or 42.0%. The increase in Commercial landscaping services revenue was driven by increased contract revenue and to a lesser extent ancillary services.

Maintenance Services Segment Adjusted EBITDA

Segment Adjusted EBITDA for the three months ended June 30, 2026 decreased by \$18.7 million to \$63.0 million from \$81.7 million in the 2025 period. Segment Adjusted EBITDA Margin decreased 390 basis points, to 12.2%, in the three months ended June 30, 2026, from 16.1% in the 2025 period. Development Services Net Service Revenues

Development Services net service revenues for the three months ended June 30, 2026 remained relatively flat, increasing \$0.6 million, or 0.3%, compared to the 2025 period.

Development Services Segment Adjusted EBITDA

Maintenance Services Net Service Revenues

Maintenance Services net service revenues for the nine months ended June 30, 2026 increased by \$98.0 million, or 6.9%, from the 2025 period. Snow removal services increased by \$82.7 million, or 39.2%, due to increased snowfall in the period¹ and Commercial Landscaping services increased by \$15.3 million, or 1.3%. The increase in Commercial Landscaping services revenue was driven by increases in contract and ancillary services revenues.

Maintenance Services Segment Adjusted EBITDA

Segment Adjusted EBITDA for the nine months ended June 30, 2026 decreased by \$4.7 million to \$168.0 million from \$172.7 million in the 2025 period. Segment Adjusted EBITDA Margin decreased 110 basis points, to 11.1%, in the nine months ended June 30, 2026, from 12.2% in the 2025 period. The decreases in Segment Adjusted EBITDA and Adjusted EBITDA Margin were primarily driven by a non-routine self-insurance adjustment, and continued investments in our sales force, partially offset by increased snow removal services and commercial landscaping revenue described above.

Development Services Net Service Revenues

Development Services net service revenues for the nine months ended June 30, 2026 decreased \$34.3 million, or 6.1%, compared to the 2025 period. The decrease was driven by the timing and mix of Development Services projects.

Development Services Segment Adjusted EBITDA

Segment Adjusted EBITDA for the nine months ended June 30, 2026 decreased \$5.5 million, to \$60.6 million, compared to the 2025 period. Segment Adjusted EBITDA Margin decreased 30 basis points to 11.4% for the nine months ended June 30, 2026, from 11.7% in the 2025 period. Liquidity and Capital Resources

Liquidity

Our principal sources of liquidity are existing cash and cash equivalents, cash generated from operations and borrowings under the Credit Agreement and the Receivables Financing Agreement. Our principal uses of cash are to provide working capital, meet debt service requirements, fund capital expenditures and finance strategic plans, including acquisitions and share repurchases under the share repurchase program announced in March 2025, and updated in November 2025 to increase the authorized amount of repurchases to a total of \$150 million. We may also seek to finance capital expenditures under finance leases or other debt arrangements that provide liquidity or favorable borrowing terms. We continue to consider acquisition opportunities, but the size and timing of any future acquisitions and the related potential capital requirements cannot be predicted. While we have in the past financed certain acquisitions with internally generated cash, in the event that suitable businesses are available for acquisition upon acceptable terms, we may obtain all or a portion of the necessary financing through the incurrence of additional long-term borrowings.

Based on our current level of operations and available cash, we believe our cash flow from operations, together with availability under the Revolving Credit Facility under the Credit Agreement and the Receivables Financing Agreement, will provide sufficient liquidity to fund our current obligations, projected working capital requirements, debt service requirements and capital spending requirements and share repurchases for the next twelve months and the foreseeable future.

A substantial portion of our liquidity needs arise from debt service requirements, and from the ongoing cost of operations, working capital and capital expenditures.

The Company is party to the Credit Agreement, a five-year revolving credit facility that, as amended, currently matures on April 22, 2031, subject to a springing maturity date based on earlier maturing outstanding term loan indebtedness (the “Revolving Credit Facility”) and, through a wholly-owned subsidiary, a receivables financing agreement dated April 28, 2017 (as amended, the “Receivables Financing Agreement”). Each of the Company’s credit facilities bear interest based in-part on a secured overnight financing rate.

We can increase the borrowing availability under the Credit Agreement or increase the term loans outstanding under the Credit Agreement by up to \$303.0 million, in the aggregate, in the form of additional commitments under the Revolving Credit Facility and/or incremental term loans under the Credit Agreement, or in the form of other indebtedness in lieu thereof, plus an additional amount so long as we do not exceed a specified senior secured leverage ratio and, in the case of second lien indebtedness, a specified senior secured leverage ratio. We can incur such additional secured or other unsecured indebtedness under the Credit Agreement if certain specified conditions are met. Our liquidity requirements are significant primarily due to debt service requirements. See Note 7 “Long-term Debt” to our unaudited consolidated financial statements included under Part I, Item 1, “Financial Statements”.

The Company is party to the Investment Agreement dated August 28, 2023, pursuant to which the Company issued and sold, in a private placement, an aggregate of 500,000 shares of the Company’s Series A Convertible Preferred Stock, for an aggregate purchase price of \$500.0 million. The Series A Convertible Preferred Stock is entitled to dividends at a rate of 7.0% per annum, compounding quarterly, paid in kind or paid in cash, at the Company’s election.

Our business may not generate sufficient cash flows from operations or future borrowings may not be available to us under our Revolving Credit Facility or the Receivables Financing Agreement in an amount sufficient to enable us to pay our indebtedness, or to fund our other liquidity needs. Our ability to do so depends on, among other factors, prevailing economic conditions, many of which are beyond our control. In addition, upon the occurrence of certain events, such as a change in control, we could be required to repay or refinance our indebtedness. We may not be able to refinance any of our indebtedness, including the Series B Term Loan under the Credit Agreement, on commercially reasonable terms or at all. Any future acquisitions, joint ventures, or other similar transactions may require additional capital and there can be no assurance that any such capital will be available to us on acceptable terms or at all.

Cash Flows provided by Operating Activities

Net cash provided by operating activities for the nine months ended June 30, 2026 decreased \$79.1 million to \$128.3 million, from \$207.4 million in the 2025 period. This decrease was primarily due to a decrease in cash provided by unbilled and deferred revenue, and accounts receivable.

Cash Flows (used) by Investing Activities

Net cash used by investing activities increased \$13.9 million to \$165.3 million for the nine months ended June 30, 2026 from \$179.2 million in the 2025 period. The increase was primarily driven by a \$17.0 million decrease in capital expenditures in comparison to the prior period.

Cash Flows (used) by Financing Activities

Net cash flows used by financing activities of \$23.1 million for the nine months ended June 30, 2026 included repurchase of common stock and distributions of \$42.8 million, repayments of finance lease obligations of \$40.8 million, Series A preferred stock dividends of \$26.9 million, repayments under the Receivables Financing Agreement of \$13.0 million, and debt issuance and prepayment costs of \$10.4 million. These uses of cash were partially offset by proceeds from our Receivables Financing Agreement of \$104.5 million and increase in book overdrafts of \$5.6 million.

Adjusted Free Cash Flow

Adjusted Free Cash Flow decreased \$63.0 million to an outflow of \$37.2 million for the nine months ended June 30, 2026 from an inflow of \$25.8 million in the 2025 period. The decrease in Adjusted Free Cash Flow was due to a decrease in net cash provided by operating activities, partially offset by a decrease in cash used for capital expenditures, each as described above.

Net working capital is defined as current assets less current liabilities. Net working capital decreased \$18.4 million to \$133.4 million as of June 30, 2026, from \$151.8 million as of September 30, 2025, primarily driven by a decrease in cash and cash equivalents of \$60.1 million, increase in current portion of long term debt of \$7.4 million and decrease in unbilled revenue of \$2.0 million. This was partially offset by decreases in accrued expenses and other current liabilities of \$20.3 million, accounts payable of \$18.7 million, and deferred revenue of \$8.4 million and an increase in accounts receivable, net of \$7.9 million.

OBJECTIVE - Promotes compliance with federal and state securities laws with respect to (i) trading in securities while in possession of material nonpublic information and (ii) disclosing material nonpublic information.

1. **Summary and Purpose**

This Insider Trading Policy (the “Policy”), as well as federal and state securities laws, prohibit all directors, officers, employees, contractors and consultants of BrightView Holdings, Inc. (the “Company”) from (1) trading in securities of the Company, or securities of any other company with which we do business, while in possession of material nonpublic information about the Company or such other company, and (2) disclosing such material nonpublic information to others who might trade in such securities.

The Securities and Exchange Commission (the “SEC”) and the New York Stock Exchange are very effective at detecting such “insider trading,” and penalties for insider trading can include lengthy jail terms and large monetary fines. To avoid inadvertent insider trading by persons who from time to time may be aware of material nonpublic information about the Company, directors, executive officers and others who may be designated by the Company’s Chief Legal Officer (collectively, the “Covered Persons”) are subject to additional trading pre-clearance procedures and blackout periods as set forth in the Addendum attached as Appendix A to this Policy.

Additionally, to avoid the selective disclosure of material nonpublic information, to promote consistent, accurate, broad and timely public communications about the Company and to ensure compliance by the Company with SEC rules, all directors, officers, employees, contractors and consultants are prohibited from disclosing material nonpublic information about the Company and speaking on behalf of the Company with members of the investment community (including stockholders who might trade on the information) except as permitted by this Policy.

2. **Background and Penalties for Noncompliance**

Federal and state securities laws prohibit the purchase or sale of a company's securities by persons who are aware of material information about that company that is not generally known or available to the public. These laws also prohibit persons who are aware of such material nonpublic information from disclosing this information to others who may trade. Companies and their controlling persons may also be subject to liability if they fail to take reasonable steps to prevent insider trading by company personnel.

2.1 **Legal Penalties.** Legal penalties for insider trading violations may include: (1) imprisonment, (2) criminal fines, (3) civil penalties, (4) civil enforcement injunctions and (5) prejudgment interest. A person who violates insider trading laws by engaging in transactions in a company’s securities when he or she has material nonpublic information can be sentenced to a substantial prison term, criminal fines of up to \$5 million and civil penalties of up to three times the profit gained or loss avoided.

2.2 **Company-imposed Penalties.** If you violate this Policy, the Company may take disciplinary action against you, including termination, whether or not your violation of this Policy results in a violation of law.

3. **Scope of Policy**

The Company has adopted this Policy both to help Company personnel avoid the severe consequences associated with violations of the insider trading laws and to satisfy the Company's obligation to prevent insider trading. This Policy also is intended to prevent even the appearance of improper conduct on the part of anyone employed by or associated with the Company.

- 3.1 **Persons Covered.** This Policy applies to you if you are a director, officer, employee (including full-time or part-time employee and intern), contractor or consultant of the Company or its subsidiaries. Furthermore, the same restrictions that apply to you also apply to your family members who reside with you, anyone else who lives in your household, any family members who do not live in your household but whose transactions in Company securities are directed by you or are subject to your influence or control (such as parents or children who consult with you before they trade in Company securities) and any entities whose transactions in Company securities are directed by you or subject to your influence or control (such as a trust or other entity). You are responsible for making sure that the purchase or sale of any security by any such person or entity complies with this Policy.
- 3.2 **Companies Covered.** The prohibition on insider trading in this Policy is not limited to trading in the Company's securities. It includes trading in securities of other firms such as customers, suppliers or competitors of the Company and securities of firms with which the Company may be negotiating major transactions, such as an acquisition, investment or sale. Information that is not material to the Company may nevertheless be material to other firms.
- 3.3 **Securities Covered.** The restrictions in this Policy apply to "securities" of every kind, including: (1) equity securities (such as common stock), (2) debt securities (such as notes, bonds, convertible securities and debentures) and (3) options, warrants or other derivative securities.
- 3.4 **Transactions Covered.** This Policy contains certain restrictions on "trading" or "transactions" in securities. For purposes of this Policy, "trading" or "transactions" includes any (1) purchase or sale; (2) writing of puts or calls; (3) entering into a hedging transaction; or (4) making or modifying any instructions or investment options under a 401(k) plan or, unless such restriction is waived or modified by the Chief Legal Officer, or employee stock purchase plan that could result in any of the foregoing. Bona fide gifts of Company securities are not subject to the restrictions of this Policy, except for the pre-clearance requirements with which Covered Persons subject to Appendix A must comply.

4. **Statement of Policy**

4.1 **No Trading on Inside Information.**

- You may not trade in the Company's securities, either for yourself or on behalf of others (other than pursuant to a written trading plan that complies with SEC Rule 10b5-1, as explained further in the Addendum), unless you are certain that you do not possess material nonpublic information relating to the Company. You may not enter into or modify a 10b5-1 plan without first obtaining the approval of the Company's Chief Legal Officer. The Chief Legal Officer is under no obligation to pre-clear any

10b5-1 plan and may determine not to clear it or to pre-clear it only if certain conditions are satisfied. Any 10b5-1 plan must be submitted to the Company's Chief Legal Officer for approval five days prior to the entry or modification of such plan.

- Similarly, you may not trade in the securities of any other company unless you are certain you do not possess any material nonpublic information about that company which you obtained in the course of your employment or other relationship with the Company.
- You may not trade while you possess material nonpublic information even if you believe that the information has not influenced your trading decision—in other words, even if you would have traded without having the information.
- **No Tipping.** You may not pass material nonpublic information on to others or recommend to anyone the purchase or sale of any securities when you are aware of such information. This practice, known as "tipping," also violates the securities laws and can result in the same civil and criminal penalties that apply to insider trading, even though you did not trade and did not gain any benefit from another's trading. To avoid tipping someone about material nonpublic information, you should:
 - tell material nonpublic information to other Company personnel only on a "need to know" basis for authorized Company purposes;
 - never discuss the Company in an internet chat room or bulletin board or other type of public forum where Company securities are a topic; and
 - never discuss material nonpublic information through social media of any kind or in public areas where others might overhear it.
- **No Short Sales.** Short sales of the Company's securities evidence an expectation on the part of the seller that the securities will decline in value and therefore signal to the market that the seller has no confidence in the Company or its short-term prospects. In addition, short sales may reduce the seller's incentive to improve the Company's performance. For these reasons, short sales of the Company's securities are prohibited by this Policy. In addition, Section 16(c) of the Securities Exchange Act of 1934 (the "Exchange Act") prohibits directors and officers from engaging in short sales.
- **Options Trading.** A transaction in options is, in effect, a bet on the short-term movement of the Company's stock and therefore creates the appearance that the director, officer or other employee is trading based on inside information. Transactions in options also may focus the person's attention on short-term performance at the expense of the Company's long-term objectives. Accordingly, transactions in puts, calls or other derivative securities relating to the Company are prohibited.
- **Margin Accounts and Pledges.** Securities held in a margin account may be sold by the broker without the customer's consent if the customer fails to meet a margin call. Similarly, securities pledged as collateral for a loan may be sold in foreclosure if the borrower defaults on the loan, or in many instances, if the value of the collateral declines. Because a margin sale or foreclosure sale may occur at a time when the customer or borrower is aware of material nonpublic information regarding the Company or otherwise is not permitted to trade in Company securities, caution should be exercised in holding Company securities in a margin account or pledging Company securities as collateral for a loan. Moreover, due to heightened scrutiny and public disclosure requirements, directors and others who are required to file stock ownership reports with

the SEC under Section 16(a) of the Securities Exchange Act of 1934 are required to notify the

Company's Chief Legal Officer at least two days prior to depositing Company securities in a margin account or pledging Company securities as collateral for a loan.

4.6 *No Exception for Hardship*. The existence of a personal financial emergency does not excuse you from compliance with this Policy and laws prohibiting insider trading.

4.7 *Prediction Markets*. Use of confidential information on prediction markets – whether such information belongs to the Company or to a business partner – may violate Company policy and result in disciplinary measures.

5. ***Definition of Material Nonpublic Information***

In order to determine whether you possess “material nonpublic information,” you must consider both the materiality and public availability of the information in your possession.

5.1 *Material Information*. Information is generally regarded as “material” if there is a substantial likelihood that a reasonable investor would consider it important in deciding whether to buy, hold or sell a security. Any information that could reasonably be expected to affect the price of the security is material. Common examples of material information are:

- earnings or projections of future earnings;
- significant changes in sales volume, market share, product pricing or mix of sales;
- a change in business strategy;
- material labor negotiations or disputes, including possible strikes;
- a significant pending or proposed acquisition or disposition;
- a change in senior management;
- major events regarding the Company's securities, including the declaration of a stock split, a change in dividend policy, the offering of additional securities or the repurchase of securities;
- changes in long-term debt ratings;
- financial liquidity problems;
- actual or threatened major litigation, or the resolution of such litigation;
- material cybersecurity risks or incidents experienced by the Company;
- matters relating to inquiries or investigations by governmental agencies; and
- new major contracts, orders, markets, suppliers, customers or finance sources, or the loss thereof.

Note: The above list is intended to be illustrative and is not exhaustive or comprehensive. Whether any particular information could be considered material by a “reasonable” investor depends on the specific circumstances existing at a particular point of time.

Both positive and negative information can be material. Material information is not limited to historical facts but

may also include projections and forecasts. Because trading that receives scrutiny will be evaluated after the fact with the benefit of hindsight, questions concerning the materiality of particular information should be resolved in favor of treating the information as material and trading should be avoided.

5.2 **Nonpublic Information.** Nonpublic information is information that is not generally known or available to the public. The fact that information has been disclosed to a few members of the public does not make it public for insider trading purposes. Information is considered to be available to the public only when it has been released broadly to the marketplace (such as by a press release, a webcast conference or an SEC filing) and the investing public has had time to absorb the information. Unless special circumstances warrant a different period, as a general rule, information about the Company is considered nonpublic until the beginning of the second full trading day after the date on which the information is released. For example, if the Company were to issue a press release disclosing material nonpublic information of which you were aware (such as periodic earnings information) before the opening of the market on a Tuesday, the first time you can buy or sell Company securities is the opening of the market on Thursday (assuming you are not aware of other material nonpublic information at that time).

6. Certain Exceptions

6.1 **Employee Benefit Plans.** The restrictions on trading set forth in this Policy do not apply to the periodic contributions by the Company or by employees to employee benefit plans (e.g., a 401(k) plan or employee stock purchase plan) which are used to purchase Company securities pursuant to an employee’s advance instructions. However, an employee may not alter his or her instructions regarding the purchase or sale of Company securities in such plans, or make discretionary transfers into or out of Company securities in such plans, while in the possession of material nonpublic information; the Chief Legal Officer, however, may waive or modify the foregoing restrictions with respect to an employee stock purchase plan.

6.2 **Stock Options.** The trading prohibitions and restrictions in this Policy do not apply to the exercise of stock options under the Company’s stock option plans. However, such prohibitions and restrictions do apply to any sales of Company securities acquired upon the exercise of stock options (including by means of “cashless exercise”). The delivery to the Company of Company securities that you already own in payment of an option exercise price is not subject to this Policy because it does not involve any market sale of Company securities. Similarly, this Policy does not apply to an election by you to have the Company withhold shares to satisfy tax withholding obligations upon your exercise of an option.

7. Selective Disclosure Policy

7.1 **Background.** Regulation Fair Disclosure, or “Regulation FD,” promulgated by the SEC under the Securities Exchange Act of 1934, is designed to prevent public companies from selectively disclosing material nonpublic information to members of the financial community and to instead promote dissemination of material

nonpublic information to all members of the investing public at the same time. More specifically, Regulation FD requires public companies to make public disclosure of any material nonpublic information about the company or its securities simultaneously with the communication of that information by the company or any person acting on its behalf to any member of the Investment Community (defined below in Section 7.2).

7.2 Scope of Policy.

- Regulation FD and this Policy prohibit selective disclosure to certain specified persons, including (1)

broker-dealers and persons associated with them, including investment analysts; (2) investment advisers, certain institutional investment managers and their associated persons; (3) investment companies, hedge funds, and affiliated persons; and (d) any stockholder under circumstances in which it is reasonably foreseeable that the stockholder will purchase or sell the company's securities on the basis of the information (collectively referred to in this Policy as the "Investment Community").

- Use of social networks, including corporate blogs, employee blogs, chat boards, Facebook, LinkedIn, Twitter, YouTube and any other non-traditional means of communication, to disclose material nonpublic information is considered selective disclosure to the Investment Community and is therefore governed by this Policy.
- **Statement of Policy.** The Company is committed to the fair disclosure of information about the Company without advantage to any particular investor or other member of the investment community consistent with Regulation FD. Selective disclosure of material nonpublic information about the Company in violation of this Policy or applicable law is prohibited. It has been and will continue to be the Company's policy and practice to disclose material information about the Company publicly and on a timely basis, as required by law or as determined by the Company to be appropriate.

To ensure the Company's compliance with Regulation FD and to promote consistent, accurate and timely communications to all investors, it is the Company's policy that material nonpublic information about the Company may only be disclosed to members of the Investment Community by the Chief Executive Officer or the Chief Financial Officer or with their prior approval.

To the extent practicable, all communications of material nonpublic information to third parties, even communications that are not to members of the Investment Community and are not covered by Regulation FD, should be made under the protection of a written confidentiality agreement.

Directors, officers, employees, contractors and consultants who believe they may have disclosed (whether intentionally or unintentionally) material nonpublic information about the Company in violation of this Policy are required to contact the Chief Legal Officer immediately so that the Company can determine if any corrective measures need to be taken.

7.4 Quiet Periods. As part of our commitment to consistent and transparent communication, the Company will observe a formal quiet period, starting at quarter end and continuing to the date of our earnings release. During this time, we will refrain from taking meetings with investors and analysts or attending conferences.

- ***Post-Termination Disclosure***

This Insider Trading and Selective Disclosure Policy continues to apply to you even after you have terminated employment or other services to the Company or a subsidiary. If you are aware of material nonpublic information when your employment or service relationship terminates, you may not trade in Company securities or disclose the material nonpublic information until that information has become public or is no longer material.

9. *Responsibility of Managers*

Managers are responsible for ensuring that all personnel who report to them understand this Insider Trading and Selective Disclosure Policy. This includes any employee who might only remotely come into possession of material nonpublic information.

10. *Company Assistance*

Your compliance with this Policy is of the utmost importance both for you and the Company. If you have any questions about this Policy or its application to any proposed transaction, you may obtain additional guidance from the Company's Chief Legal Officer. Do not try to resolve uncertainties on your own, as the rules relating to insider trading and selective disclosure of material nonpublic information are often complex, not always intuitive and can carry severe consequences.

This Insider Trading and Selective Disclosure Policy supersedes all previous policies of the Company concerning insider trading and selective disclosure of material nonpublic information.

1. *Introduction*

Appendix A

Addendum to Insider Trading and Selective Disclosure Policy

The Company has adopted this Addendum to the BrightView Landscapes Insider Trading and Selective Disclosure Policy to:

- help prevent inadvertent violations of the federal securities laws and to avoid even the appearance of trading on inside information (which could result, for example, when a director or an executive officer engages in a trade while unaware of a pending material development);
- assist directors and executive officers in complying with their SEC Forms 3, 4, 5 and 144 filing obligations; and
- help directors and executive officers avoid inadvertent "short swing" (i.e., six months) profit liability.

The restrictions set forth in this Addendum are in addition to, and do not limit, the restrictions set forth in the Insider Trading and Selective Disclosure Policy.

- ***Persons Covered***

The provisions of this Addendum apply only to directors of the Company, officers of the Company that are subject to the securities reporting requirements of Section 16 of the Securities Exchange Act of 1934, and other individuals that may from time to time have access to material nonpublic information about the Company and, as a result, may be designated by the Company's Chief Legal Officer as being subject to this Addendum (collectively, "Covered Persons"). The Company will notify these other individuals when they are subject to this Addendum.

- ***Gifts Covered***

Gifts, contributions to trusts and other similar transfers of securities are subject to the pre-clearance procedures set forth in this Addendum but not to the restrictions of the Insider Trading and Selective Disclosure Policy itself.

- ***Certain Exceptions***

The transactions that are excepted from the insider trading policy pursuant to Section 6.1 of the Policy are also excepted from the requirements and restrictions of this Addendum.

- ***Pre-Clearance Procedures***

Because Covered Persons are likely to obtain material nonpublic information on a regular basis, the Company requires all such persons to refrain from trading, even outside a blackout period under Section 6, without first pre-clearing all transactions in the Company's securities.

A Covered Person and his or her family members and others who are subject to his or her control or

influence may not engage in any transaction involving the Company's securities (including a stock option exercise, loan, pledge, hedge, gift, contribution to a trust or other transfer) at any time without first obtaining pre-clearance of the transaction from the Company's Chief Legal Officer.

A request for pre-clearance should be submitted in advance of the proposed transaction. If the Chief Legal Officer approves a proposed transaction, the transaction must be effected within two business days following the date proposed or the pre-clearance will expire. However, if the Covered Person becomes aware of material nonpublic information before the approved transaction is executed, he or she should not effect the transaction.

The Chief Legal Officer is under no obligation to approve a transaction submitted for pre-clearance and may determine not to permit the transaction. Covered Persons are cautioned that ultimate responsibility for determining whether they possess material nonpublic information rests with them. Approval of a transaction under the pre-clearance procedure will not necessarily insulate the Covered Person from liability under the federal securities laws.

- **Blackout Periods**

6.1 Quarterly Blackout Periods. A Covered Person and his or her family members and others who are subject to his or her control or influence may not engage in any transaction involving the Company's securities during the period from the 15th day of the last month of each fiscal quarter until the opening of business on the second full trading day following the date of release of the Company's earnings for such fiscal quarter. For example, if the Company were to release its first quarter earnings on January 15th, then the applicable blackout period for the first quarter would begin on December 15th and end at the opening of business on January 17th. The Company will announce when a blackout period has ended and when the next blackout period is expected to begin.

6.2 Other Blackout Periods. The Company's Chief Legal Officer may establish additional event-specific blackout periods. The Company will notify you of any additional blackout periods.

- **Exception for Approved 10b5-1 Plans**

Transactions in Company securities made pursuant to an approved SEC Rule 10b5-1 plan as described below, commonly referred to as "10b5-1 plans," are not subject to: (a) the prohibition on trading on the basis of material nonpublic information contained in the Insider Trading Policy, (b) the pre-clearance procedures set forth above or (c) the blackout period restrictions set forth above. Rule 10b5-1 provides an affirmative defense from insider trading liability under the federal securities laws for 10b5-1 plans. The general features of a 10b5-1 plan include the following:

- you must enter into the 10b5-1 plan at a time when you do not possess any material nonpublic information and a blackout period does not exist;
- the 10b5-1 plan must either specify in advance the amount, pricing and timing of future transactions (or provide a formula for determining such items) or delegate discretion on those

matters to an independent third party such as a broker; and

- after you adopt the 10b5-1 plan, you must not exercise any influence over the amount of securities to be traded, the price at which they are to be traded or the date of the trade (i.e., all of such matters must be determined by the broker as specified in the plan).

The following requirements apply to all 10b5-1 plans:

- directors and officers of the Company that are subject to the securities reporting requirements of Section 16 of the Securities Exchange Act of 1934 (collectively, "Section 16 Insiders") may not commence sales under a 10b5-1 plan until the later of (i) 90 days following the date of adoption or modification of such plan; or (ii) two business days following the disclosure of the Company's financial results in a Form 10-K or Form 10-Q relating to the fiscal quarter in which the 10b5-1 plan was adopted or modified (but not to exceed 120 days following plan adoption or modification);
- all persons other than Section 16 Insiders, may not commence sales under a 10b5-1 plan until 30 days following the date of adoption or modification of such plan;
- Section 16 Insiders must provide a representation in the 10b5-1 plan certifying that, on the date of adoption or modification of the plan, they (i) are not aware of material nonpublic information about the Company or its securities; and (ii) are adopting or modifying the plan in good faith and not as part of a plan or scheme to evade the prohibitions of Rule 10b-5;
- you may not maintain multiple, overlapping plans;
- you can utilize only one single-trade plan (i.e. a plan designed to effect only a single transaction) during any 12 month period; and
- you must act in good faith with respect to the 10b5-1 plan, not just in connection with entering into the plan.

Amendments will be viewed in hindsight and could call into question whether a 10b5-1 plan was entered into in good faith. You may only amend your 10b5-1 plan at a time when you do not possess any material nonpublic information and a blackout period does not exist. As noted in the Insider Trading and Selective Disclosure Policy, a Covered Person may not enter into or modify a 10b5-1 plan without first obtaining the approval of the Company's Chief Legal Officer. The Chief Legal Officer is under no obligation to pre-clear any 10b5-1 plan and may determine not to clear it or to pre-clear it only if certain conditions are satisfied. Any 10b5-1 plan must be submitted to the Company's Chief Legal Officer for approval five days prior to the entry or modification of such plan.

- ***Post-Termination Transactions***

If you are aware of material nonpublic information when you terminate service as a Covered Person, you may not trade in Company securities until that information has become public or is no longer material. In all other respects, the procedures set forth in this Addendum will cease to apply to your transactions in Company securities upon the expiration of any blackout period that is applicable to your transactions at the time of your termination of service.

9. Company Assistance
