### **Completion of Disposition of Progressive Produce**

On March 13, 2024, Dole plc (“Dole” or the “Company”) completed its sale of Progressive Produce LLC (“Progressive Produce”) to PTF Holdings, LLC (“PTF Holdings”), a Delaware limited liability company and portfolio company of Arable Capital Partners, LLC (“Arable”). As a result of the sale of Progressive Produce, Dole has received gross proceeds of \$120.25 million in cash.

## **Dole plc Announces Completion of Sale of Progressive Produce to Arable Capital**

Dublin – March 13, 2024

Dole plc (NYSE: DOLE) (“Dole”) has today announced that it has completed the previously announced sale of its 65% equity stake in Progressive Produce LLC to PTF Holdings, LLC (“PTF Holdings”), the parent company of Pacific Trellis Fruit, LLC. PTF Holdings is a portfolio company of Arable Capital Partners, LLC (“Arable”). Dole has received gross cash proceeds of \$120.25 million from this sale.
